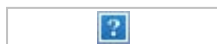

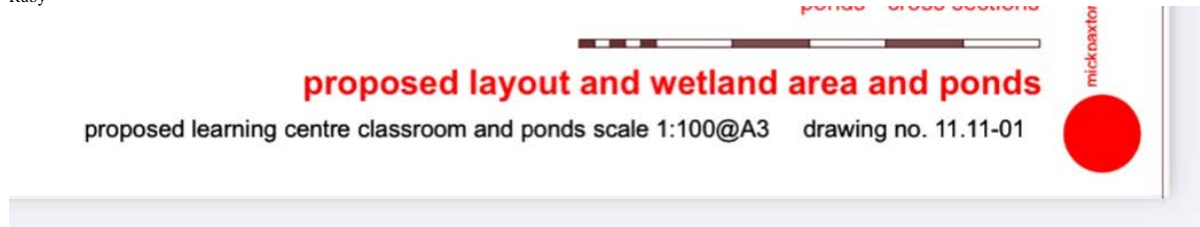

Hello,

I refer to the letter we received on 19th August regarding the application we have made for a polytunnel and 4 ponds at our site, and the clarification sought by the parish council.

I can confirm that our plans do not include a learning centre- there is no mention of this on our plans. The application is for ponds and a polytunnel (which we were told in pre-planning advice that the NYM would have no objections to.)

We initially had an idea to do an outdoor classroom but after seeking pre-planning advice several months ago - funded by NYM future farming grant team- we were told that this would not be permitted and so the idea has been discarded.

I trust that the application will be assessed on the details of the planning application which are wholly accurate.
