Listed Building consent for refurbishment/repair works to bell and re-installation in the cupola

Consultee response

Regarding the repair works to the bell and reinstating it at St Stephens Church, I have no concerns or issues. The bell seems to be native to the area and its return would allow its sound to be heard once more across the parish.

My concerns are linked to the structural soundness of the cupola itself. It seems that plans were approved in 2018/19 for repair works to the cupola and roof timbers below, with the inclusion of metal sections/splices. Within the supporting information attached to this application, within the DAS/HS (appendix) is a report from a Conservation Engineer (16/8/22). Within this report it is mentioned that the repairs are apparently "heavy handed", "…in places don't meet codified design practice" and, "The effects of timber decay to the truss and other secondary timbers do not appear to have been properly dealt with". In addition, the report also notes that "Introducing the effects of the bell, given its modest size and weight, gut feeling says 'probably ok:, but because the support system is difficult to prove for support of the cupola itself, it's the same for the bell. The additional effects of the bell are quite modest though, and if it's a bell that's hit with a hammer, then even smaller still". I ask that the owner/applicant ensures that the cupola is structurally sound and more than capable of not only supporting this historical bell, but also being able to withstand the forces of the bell being rung endless amounts of times over many years; I would not want to see a historic bell destroyed because of inadequate support. Does the owner/applicant have any images of the cupola works for review and/or have any information to resolve this concern?
