- 2802 and 2804 Turkey Oak Removal of dead branches and areas of tip dieback. Crown lift to 5.5m above road.
- 2851 Bay Crown Reduction Large, multi stemmed tree, shows fruiting bodies (*Ganoderma*) and associated canopy decline. Reduce crown by 1-2meters to reduce weight on stem.
- 2848 Cider Gum Fell Poorly developing tree of little value. Poorly located and impacting on other trees.
- 2843 New Zealand Cabbage Fell Species out of place and inappropriate to surrounding area.

Replacement Trees - It is not intended to plant replacement trees because:

- The site overall is well wooded
- Removal of these trees will allow adjacent trees to flourish
- It would not be viable to plant trees where honey fungus is present.
