## Background

Ryefield is a substantial eight bed dwelling situated within extensive gardens, on the edge of the village of Scalby, outside, but adjacent to the Scalby Conservation Area and close to the bridge to Newby and Scarborough.

Planning permission was granted in 2015 to subdivide the existing house into three dwellings: in the form of a four bed, five bed and three bed dwelling. Permission was also granted to construct a new substantial L-shaped five-bedroom, two storey dwelling and detached double garage, to the south eastern side of the existing dwelling at a significantly lower ground level than Ryefield. A start has been made on this permission.

A revised application was approved in 2019 to amend the design of the proposed new house and further amendments were subsequently approved to alter primarily the fenestration details but also including a small lean-to at the rear to provide utility and wc and a further variation was approved in 2021 and 2022 to allow further design amendments.

This variation of condition application seeks permission to change the size of a small single storey lean-to to a small two-storey projection to enable the provision of two first floor ensembles.

## Main issues

### Local Plan

Strategic Policy C- Design - seeks to maintain and enhance the distinctive character of the National Park, and states that development will only be supported where it is of a high quality design; incorporates good quality construction materials and design details that reflect architectural character and form of the original building or the local vernacular; the siting, orientation, layout and density complement existing buildings; the scale, height, massing and form are compatible with surrounding buildings and not have an adverse impact upon the amenities of adjoining occupiers; sustainable design and construction techniques are incorporated; there is a good quality landscaping and planting scheme; local wildlife and biodiversity is enhanced; provision is made for adequate storage, cycling facilities and car parking are provided and the proposal ensures the creation of an accessible, safe and secure environment for all potential users.

### Material Considerations

The principle of the development has already been accepted, so the issue for consideration here is whether or not the revised design would have a detrimental

impact on the character of the adjacent conservation area, the host dwelling or neighbouring amenities.

The development would retain a similar scale and bulk to the approved plans, and it is not considered that the revised side projection would have a detrimental impact on the character of the conservation area as the proposed new dwelling is set well within the grounds of the property and would not have a detrimental impact on the open character of the street scene.

The proposal is therefore considered to be in accordance with Strategic Policy C of the NYM Local Plan and consequently approval is recommended.
