

Further to receipt of the planning approval (copy attached for ease of reference) my client has now instructed me to discharge the various conditions.


We interpret that 2 or 3 actually require discharging and would appreciate your response to confirm the following:

To Whoever it may concern

I can confirm that after undertaking an ecological assessment of the site of the proposed mast and access track - both from our records and in the field - my opinion is that the works will have no impact on the population of Turtle doves nesting in the area around High Rigg.

The crop surrounding the mast area is Larch and Scots pine - planted in 1995 and is as yet un-thinned with no open areas and limited ground flora and as such is not suitable Turtle dove breeding habitat.

The nearest Turtle dove record we have is approximately 1.5 km east of the mast location at the other side of the farm fields. This area provides much more suitable habitat - it is a younger crop of Sitka spruce and birch with much more open feeding areas.
