Dear Megan

The application is supported by a Bat, Breeding Bird and Barn Owl scoping survey. Whilst no evidence was found to support use by bats, birds or owls, the building did contain numerous potential bat roost features in the form of wall crevices which could not be inspected and ruled out during the survey. As a result, to determine whether bat roosts are present, a single bat activity survey will need to be conducted in the optimum season (mid-May to August) prior to the application being determined.

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The design standard for the site is Manual for streets and that the required visibility splay is 2 metres by 11 metres. The available visibility is 2 metres by 1.5 metres looking to the north.

Consequently, the Local Highway Authority recommends that Planning Permission is **REFUSED** for the following reasons:

R2 VISIBILITY AT WIDENED ACCESS

The Planning Authority considers that clear visibility of 11 metres cannot be achieved along the public highway in a northerly direction from a point 2 metres from the carriageway edge measured down the centre line of the access and consequently traffic generated by the proposed development would be likely to create conditions prejudicial to highway safety

However if the local planning authority is minded to grant permission it is requested that the following condition and informatives are attached to the permission:

MHC-05 Visibility Splays at the widened access

There must be no access or egress by any vehicles between the highway and the application site until splays are provided giving clear visibility of 11 metres measured along all three channel lines of the major road from a point measured 2 metres down the centre line of the access to each of the two proposed parking places. In measuring the splays, the eye height must be 1.05 metres

I refer to your e-mail of the 16th December 2021 in respect of the above application. Whilst I have no objections in principle I would point out my concern in relation to fire safety.

The means of escape from the first floor bedroom is through a "high risk" kitchen area. An alternate means of escape will need to be provided. I would suggest the installation of an appropriate escape window from the bedroom area in addition to a robust fire detection system.
