I've spoken to Steve at Butter Park Farm, and we have re-run the SCAIL assessment, including the existing lagoons on site. Although the levels of N deposition will be high from the proposed lagoon, they are significantly (c4x) lower than the existing levels, and Steve has confirmed that the existing lagoons will not be used, if the new one is built. Therefore, providing that we can secure that the existing lagoons will be decommissioned, then I'm happy that the development can proceed.

Hi Lucy,

The proposed lagoon falls within an impact risk zone for air pollution for Arnecliffe and Park Hole Woods and the North York Moors designated sites. We will therefore need a SCAIL assessment to be undertaken to determine the potential impacts of the proposed development on the designated site. This can be conducted on the [SCAIL – agricultural portal \(ceh.ac.uk\)](https://ceh.ac.uk/scail/) free of charge. Although there is no specific option for a slurry lagoon, it can be unput as a tank, using the maximum size the lagoon can hold.

I recommend that the applicant exports the results into a .csv file which can be opened in Excel, and also takes a screenshot of the inputs used and submit this too – this means if there are any issues found with the data then it is easier for us to pinpoint where this could be or replicate the assessment if necessary.
