This building is a demonstration project developed by Material Cultures in collaboration with Central Saint Martin's University students.

As well as being a functional place in which to enjoy the view over the fantastic landscape of the North York Moors and shelter from inclement weather, the building itself is a teaching tool and an exemplary construction demonstrator project which is the culmination of Material Cultures' work on the decarbonizing the construction economy in the North East and Yorkshire, and their ongoing research project Constructive Land which explores the future of forestry and farming and their relationship to the construction industry.

The building will host interpretation of the building as well as the adjacent Forest Eye, which highlights the subject of sustainability with young people.
