I've had these 2 applications flagged up, as they may have trees nearby:



Hi Jill,

I can't tell from the documents submitted with this application if any tree removal is proposed to facilitate the stable build, or how large the footprint of the development is- from the cross sections it looks like there will be an area of hard standing in from of the stables, but no information on how big this area will be is provided. From the size of the stables, it looks like this development will be larger than the de minimis threshold for BNG (<25m2) and semi-natural habitat will be lost to facilitate the development. I would therefore recommend a Biodiversity Net Gain assessment is completed for this development. If there is no priority habitat onsite, then it is possible that this that the Natural England Small Sites Metric could be used. It should be noted that, whilst it is not essential that the metric is completed by a suitably qualified ecologist, the base requirement for this metric is that it must be completed by a 'competent person'. This is defined as someone who; "is confident in identifying habitats present on the site before the development AND identifying the management requirements for habitats which will be created or enhanced within the landscape design."
