With this proposal we are requesting permission to install the Solar Array that is connected to A Room That Sings - Art installation (NYM 2021 0822FL), instead of at the end of the forest track along the PROW, in amongst the scrub vegetation on the opposite side of the PROW. This will be less visible from the PROW but more visible from the forest track. It will steer clear of the gas pipe underground and of the recorded HER (Appendix 5).
