Officer 1 (31/10/2023) - With regards to your second query, I would draw your attention to Policy CO13 of the Local Plan. This Policy sets out very clearly that if there has been a period of unsuccessful marketing of a local occupancy dwelling, this condition would only be replaced with a Principal Residence condition. An application to vary the condition to allow any holiday letting use would be entirely contrary to Policy and would not be supported.

Officer 2 (27/10/2023) - It was decided that Scar View had been satisfactorily marketed for a reasonable period to establish whether or not there was a demand for the accommodation. The asking price included a reasonable reduction in the open market valuation to reflect the local occupancy restriction. However, the interest in the property from qualifying persons had been limited and no offers were forthcoming.
