## **Holding Comment**

Thorpe Hall is a grade 2 listed building in the Fylingthorpe Conservation Area. Therefore, this application has been determined in accordance with Section 66 and 72 of the Planning (Listed Buildings and Conservation Areas) Act 1990. Chapter 16 of the NPPF paragraphs 189, 194, 195 and 200 as well as, Policy ENV11 of the North York Moors National Park Authority Local Plan (July 2020).

The greenhouse in question is constructed in timber with its base in gault brickwork. The greenhouse appears to be early/mid 20th century and is in a dilapidated condition with many un-sympathetic additions such as modern blockwork. Its removal is not objected to. Its replacement with a traditional style aluminium greenhouse with imperial red reclaimed brickwork to the base will sit nicely in the grounds of the grade 2\* listed building. The walling around the greenhouse will be in red reclaimed brickwork with a stone coping. This is not unusual for walled gardens to be constructed in brickwork as they traditionally retained their heat in the garden better than stone.

The concern is the proposed access gate in reclaimed brickwork abutting the stone stable.

Whilst this is of a good design, on reflection the building is constructed in stone as well as its stable range and its historic walls at present.

I have concerns about too much brickwork being added into the garden onto a plot where there is very little at present.

We would want to see the new access gates and wall constructed in stone to match the property. The walling around the proposed greenhouse to create a walled garden is not objected to in reclaimed red imperial bricks.
