#### **Note to the Planning Officer:**

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The access onto the public highway is adequate for the amount of traffic. However, the vegetation needs to be maintained to avoid blocking the vision splays for drivers exiting the

Consequently the Local Highway Authority recommends that the following **Condition** is attached to any permission granted:

MHC-05 Visibility Splays at Fairhead, Grosmont

There must be no access or egress by any vehicles between the highway and the application site until splays are provided giving clear visibility of 120 metres measured along both channel lines of the major road from a point measured 2.4 metres down the centre line of the access road. In measuring the splays, the eye height must be 1.05 metres and the object height must be 1.05 metres. These visibility splays must be maintained clear of any obstruction and retained for their intended purpose at all times.

Will any provision be made for parking off the track?


