In response to the applicants response to my comments, I'd like to clarify/correct the following points, however I can assure you that this time it will not be 8 pages: -

- It was the applicant's co-director and not the applicant who was one of the biggest complainers when the large wagon got stuck. He was trying to go buy milk for his business and if I recall correctly goto a hospital appointment. Therefore I do think he was totally correct to complain. Especially when the council and police refused to help the situation.
- We do not get our beach toys delivered to the shop. We used to and realised the vehicle was too big to be coming down the bank. We now get these delivered either to our home address in Scarborough or my fathers farm. I also believe that the other shops doing beach toys in lower RHB do the same for this reason.
- In regard to the traffic congestion I agree with Mr Kemp we see the worst of it outside of our shop and therefore we are accurately able to comment on how bad the situation is getting. 2 Transit / Sprinter vans can pass each other at several points in the village. The larger vehicles cannot be passed as easily and therefore cause more major issues.along with people with lower than average driving skills and those who just panic about the tightness of the road.
- I believe the applicant has underestimated the bulkiness of beach items and to carry them from Fisherhead to the premises would not be easy. Also the storage requirement to get a delivery once a year would be very large. In addition would a Luton Van be able to get up Fisherhead? The wall on the bridge has had to be repaired once due to a vehicle strike.

I can confirm that my position remains unchanged. I have **no objection** to The Tea Hut selling Beach Items. To solve the issues with potential traffic issues would the applicant be able to meet the delivery vehicle at the loading bay at the top of the bank opposite The Victoria Hotel as we do with many of our deliveries in larger vehicles.

I feel that I did not state my concern regarding traffic when a situation occurs due to this. I would not have any right to comment or complain as I had not raised the issue in the first place.

When planning permission was granted for The Old Coastguards station to be turned into cafe a restriction was placed stating deliveries had to before a certain time, I think 10 or 11 am if I recall correctly.

This obviously indicates you correctly assumed there is an issue in the area with traffic.

At present The Tea Hut as a take away cafe requires regular deliveries of small ish items which are normally delivered it smaller vans. Beach items are bulky items and as such as delivered in larger vans (normally Luton Vans) the last thing we need is more large vans coming into the village.

I have no objection to The Tea Hut selling these items but if permission is granted please would you consider the traffic issues in Lower Robin Hood's Bay.

Also attached are emails to the parish council acknowleding there is a problem and to be date apart from a new sign nothing has been done. The sign has not improved the situation. The latest response from Highways was: -

"Dear Mr & Mrs Bancroft.

With regards to your further email on this matter, please see our responses below;

• What would happen if the emergency services needed to be down here while the road was blocked? Would the council be taking responsibility if anything happens due to any delays? Has a risk assessment been done in relation to this? (You cannot deny that you have been made aware of the issue and my several emails prove this)

The responsibility for any delays caused by a blocked vehicle would have to be taken by the driver who caused the obstruction. In your opinion you say that the signs don't work, but like all signs, speed restriction signs, bend signs, chevron marker signs etc, drivers chose whether to obey the signs or not. We cannot control the decisions an individual driver makes. A signs only "works" if drivers react appropriately to the messages. We work closely with the emergency services and if they ever have access concerns they discuss these with us. They have not raised concerns with us about access to Robin Hoods Bay.

• Has a risk assessment been undertaken in regard to wide / long vehicles striking the buildings on Laurel Corner?

Again, it is the drivers responsibility to be in control of their vehicle at all times, it is not the responsibility of North Yorkshire Council as the 'highways authority' to carry out risk assessments for every bend, hill, narrow section on every highway in the County. Drivers need to assess every situation they come to on the road and carry out dynamic risk assessments for each situation they approach. This is the very basis of driver education.

• Has a risk assessment been undertaken in regard to a brake failure occurring on Bay Bank? This has happened before with the JCB in the 90s. I feel it is only a matter of time before this happens again. The damage caused by either HGV would be a lot more serious than that caused by either a car or LGV.

If we did work based on a chance occurrence like a JCB with brake failure we would be looking at other roads before we did anything in Robin Hood's Bay

• Has the council got a plan to recover HGV if they do get stuck down here again because the size of recovery vehicle required would probably not be able to come down? Again is this included in any risk assessments?

You are talking about a scenario that would be due to a drivers negligence or incompetence – It would be for the owner of the vehicle or their insurance company to arrange recovery.

• On Saturday the Breezemont vehicle could have easily got wedged between The Old Drapery and Bay Fisheries, what would have happened then? The wagon burned its gearbox out and had to be recovered, luckily by this point it was at a point on Bay Bank where it wasn't causing a blockage to other cars and LGVs but would have still been blocking HGV or potentially any fire engine which could have needed to be down.

Unfortunately, the lower part of Robin Hoods' Bay neds to be services by vehicles other than cars.

What would you suggest? Should we close the lower part of Robin Hoods Bay to all traffic? I can imagine we would face lots of objections from the many businesses and residents if we proposed such measures.

The Highway Code is very clear about the responsibilities drivers have and what rules they need to follow.

As someone who has been involved in road safety, driver education and development for the majority of my career it is very frustrating when people don't take responsibility for their own actions and try to blame the local authority or somebody else. Every time a driver gets behind the wheel of a vehicle they are in charge of something that has the power to kill or seriously injury someone else, let alone damage a building or block the highway. The consequences of drivers acting irresponsibly can be devastating and life changing. Drivers need to follow the rules and advice in The Highway Code and pay attention to warning signs and restrictions on the network. The local authority spend public money trying to advise drivers but ultimately they have to decide to either take heed of the signs or simply ignore the advice and 'hope' it will be ok.

I am sorry that our answers may disappoint you both but we have spent a significant amount of officer time and money trying to stop drivers of long vehicles entering the lower part of Robin Hoods Bay. We have to balance the needs of all businesses and residents and if people arranging deliveries don't make it clear to their suppliers that access is limited then again we cannot be blamed when something goes wrong.
