Permission to fell and remove one Sycamore tree overhanging the road and footpath that is suffering from large amounts of deadwood in the crown and also rot pockets at 4mts on the main stem. Dead branches have already fallen on the highway and roof of the property.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
