I confirm that the proposed revisions are satisfactory in terms of dark night skies considerations. It is still recommended that a condition be attached to any permission granted, requiring details of any external lighting to be agreed with the Local Planning Authority, to ensure it is dark skies compliant.

Taken as a whole this development has a very substantial amount of glazing. However, it would appear that the net increase in glazing as a result of the additional development now proposed is quite limited. A specific potential concern however is the proposal to replace the existing and extensive heavily tinted glazing to the spa with transparent units. Although it is noted that the use of louvres in place of the current third tier of glazing would reduce the overall glazed area related to the spa, there could nevertheless be a significant overall increase in light spill from internal sources. It would be helpful if the applicant could be asked to consider this matter and suggest how effective mitigation could be achieved.

The use of low level bollard lighting in the entrance approach area, in place of existing high level post mounted units, is supported. It will nevertheless be important that dark skies compatible bollard units are installed to minimise impact as far as practicable. It is also recommended that a condition be imposed on any permission requiring the submission of full details of dark skies compatible lighting prior to installation of any new external lighting units at this development.

Hi Hilary,

I've reviewed the documents submitted as part of this application. The existing building has a substantial amount of glazing already, but I note that the proposals are to change the currently dark glazing around the spa to clear glazing and install a rooflight above the bar. These could result in additional light spill into the surrounding area. The spa and bar appear to be directly adjacent to Newholm Beck and an area of woodland. Both the watercourse and the woodland edge are linear features that may be used by a number of commuting species including otters, bats, badger and more. Increasing the light spill in this area may have a detrimental impact on these species, and on the dark sky qualities of the National Park. From the plans it can be seen that there is already existing glazing on the roof of the bar, and therefore there may already be some upwards light spill from this roof already, but the roof lantern will increase the amount of sideways light spill which would further illuminate the watercourse and woodland adjacent. Additionally, switching to clear glazing in the spa area will increase the amount of light spill this area. I would welcome some modifications from the applicant to reduce the light spill, such as a reduction in the glazing, darker glazing, restriction on spa opening hours etc. to ensure that these adjacent habitats are not unduly illuminated.
