Hi Emily,

Thank you for the site visit and further information regarding the prior notification for erection of an agricultural building as part of this application.

As suspected, the site is relatively un-developed. The ground, although superficially disturbed on the surface, appears to be wholly undisturbed and therefore has the potential for archaeological features. The wider site known as 'The Hulleys' is well known as a very complex multi-functional and multi-period site. There is evidence for activity and settlement here from the Neolithic to the Roman occupation, with each period having distinct features present and in some cases remarkably well preserved.

The proposed building is on the northeastern edge of 'The Hulleys' site, and close to the known site of a ring cairn (Bronze Age ritual(?) structure) and a Romano-British quern stone find. 'The Hulleys' has previously been proposed as a Scheduled Monument, indicating the significance of the archaeology.

I have no issue with the erection of the proposed building, but ask that conditions are applied for an archaeological watching brief to all groundworks associated with the construction. Standard conditions ARC03 and ARC04 should be sufficient, including the need for a Written Scheme of Investigation (methodology) outlining all of the archaeological practicalities to be submitted for approval before works commence.

As ever if the applicant or their appointed agents would like to discuss any of the issues raised here I am more than happy to be further consulted.

No issues with this one providing a condition is included that the building is not used for housing livestock. Guttering should be provided on the building directed to a soakaway or water storage facility to ensure that clean roof water does not mix with areas fouled by machinery thus preventing the creation of dirty water. If any external lighting is required, this should also be dark skies friendly.
