Many thanks for your latest correspondence, email - <u>16.50 - Monday, 17th</u> June 2024, the content of which is noted.

We respond, as follows:-

The glazing bars are externally fixed to the fenestration glazing, as per the attached Green Building Store detail. The windows turn but to enable them to open outwards, the tilt function will be disabled, given they would only tilt within the thickness of the external stone wall. The dwelling is already fitted with a whole house mechanical ventilation with heat recovery system supplying measured fresh filtered air to all rooms, as per approved Building Regulations requirements.

We confirm the proposed fenestration is all timber framed, painted in dark grey paint.

Revised drawings are appended that illustrate DG03 as proposed, together with an additional drawing 2021/92/104, dated <u>Monday, 17th June 2024</u> which illustrates the fenestration provision to the arched doorway reference DG03, scale 1:10 @A3.

The proposed fenestration is being specially manufactured to follow the double arched shape of the existing stone wall opening, and the existing outward opening doors are being retained externally to this opening.

Good afternoon,

Thank you for the additional drawings.

Can you confirm that the windows are to have applied glazing bars and the opening method is tilt and turn? The glazing bars are not shown on the sectional drawings and whilst I understand you have Revit, if you are able to provide a close-up section or detail of the glazing bar, that would be appreciated.

I noted from the original supporting information that they are proposed to be timber and dark grey in colour, can you also confirm if this is still the case.

Finally, can you update drawing 7 to show how the doors will look in the arched recess on the east elevation. Ideally, we would expect to see boarded or glazed doors which follow the shape of this recess. There are some examples in Part 4 of our design guide - <u>DesignGuide4cover.indd</u> (northyorkmoors.org.uk). Page 20 probably has the most useful comparison.

We write further to our earlier email with attachments to you -<u>18.25 - Tuesday, 4th June 2024</u> (appended below) and specifically in regard to the supply to you of large scale AutoCAD drawings of this proposed replacement fenestration.

These proposed replacement windows will open outwards where illustrated, but have been set back in the line of the insulation layer to eliminate cold bridging around the fenestrated openings and align with the initially approved fenestration detailing in the original Planning Change of Use Application, an environmental and planning gain in one. The frame sizes are dimensioned, with insulation being continuous from the internal wall insulation layer now installed back and returning to these propose timber frames on the cill, head and jambs.

We trust this additional information is satisfactory for you and welcome your formal approval of same, at your earliest convenience.
