Dear Mrs Ward,

Further to our conversation on the 7th of November and your email this morning, please find attached a copy of drawing **16016-30-000 Rev A**, which has been revised to acknowledge the comments and recommendations made in your letter on the 7th of November.

Just to confirm, the key revisions are:

- Dormer to front of first floor extension omitted
- Existing clay roof tiles to side extension to be reinstated on new first floor extension roof, rather than using slate
- Height of sill to front, central dormer window aligned with the dormers to either side
- I have also indicated the intent to provide ramped wheelchair access to the front door. It is likely that the client's daughter will require ramped access to the property in the future and the design of the ramp will be developed further, following a successful planning application

Please let me know if you have any further comments to make in response to the revised drawing. If it would still be possible to process the application in line with the original determination date, it would be appreciated.
