Species: Ash

Proposal:

To remove single limbs overhanging a recently constructed cabin.

Location:

Woodland on the eastern side of Stainton Dale Road.

Amenity value:

The trees concerned are not visible from the public highway owing to the presence of a tall hedge and roadside trees.

Appraisal: (see photographs below)

The application relates to four single ash trees (rather than three ash trees and one sycamore as stated in the application) growing close to a recently constructed cabin within an open area in the woodland. The trees concerned are elongated specimens, common with the habit of many of the ash trees in the woodland owing to their close planting spaces. The owner has concerns over long limbs that hang close to the cabin that may fall on to or close to the cabin. The agreed pruning points are annotated on the photographs below.

Conclusion:

The trees concerned are relatively poor individuals and it is conceivable that the relevant branches could brake out if allowed to elongate further. The pruning recommended will not in my opinion be detrimental to the individual trees and may stimulate growth lower down the trees.

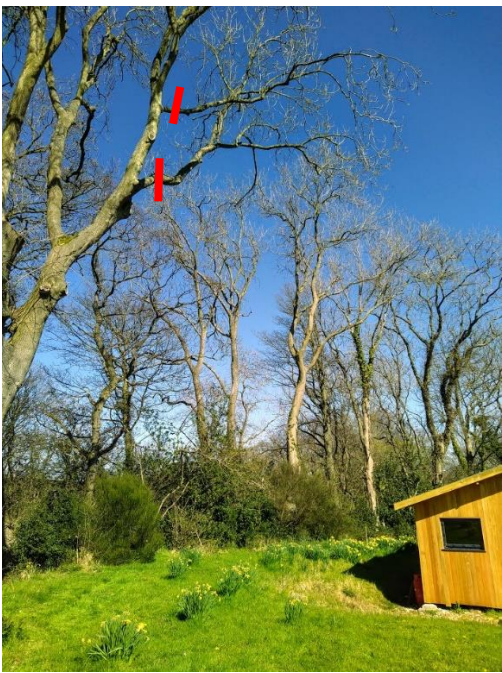
