Dear Mr Robinson,

Thank you for your reply. I appreciate that it might be a bit confusing however 'no objections' and 'support' are two very different responses in terms of an application and have implications on whether the application is determined at planning committee or by delegated powers.

From the details you have provided below I would have taken the response to be "no objection" ie the Parish council have no positive or negative comments to make on the application.

To record a response of 'support' or 'objection' this needs to be backed up with a reason for doing so on planning grounds. For example a comment of support because the applicant is a proactive member of the local community would not be on planning grounds.

If you want to discuss this further I am now back in the office and the phones are open until 5pm (I was on a course earlier however it has finished in good time hence why my out of office is on!)

Dear Mr Robinson,

I write in connection with the Parish Council's comments in relation to the above application to seek some clarification if I may.

The original comments on the 4/11/2017 stated that OAPC strongly supported the application, provided that all the works are carried out in accordance with the Conservation Officer's recommendations and respect the buildings' Listed status.

The Building Conservation Officer raised very strong objections to the proposed scheme and requested that the application was withdrawn to allow negotiations to proceed on a significantly different scheme. The applicant was keen to carry on with the current application and a meeting took place in February to discuss the significant level of alterations required. Amended plans were then finally received in October 2018 to which the Parish Council responded: "No objections have been raised. We therefore support the revised plans."

The Parish Council's comments on a planning application needs to be given on planning grounds (whether it is support or objection), alternatively a response of no objections can be given, if no comments are raised.

If you do wish to support the application I would be grateful if you could provide me with the planning grounds to go with this, alternatively you may wish to amend your recommendation to "No objection".

I look forward to hearing from you with regard to this matter so that I am able to determine the application in the appropriate manner.
