Dear Ed and Helen,

Further to our ongoing discussions concerning Atkinsons Wood Farmhouse, please find attached a suite of revised plans, responding to the various issues we recently discussed.

The attached include the following changes:

- 1. Double hung sashes revised to side hung flush casements for windows GW01, GW13, GW14, GW16, GW17
- 2. GW18 now has stable door added as with other barn door sized openings.
- 3. FW09 corrected to match elevation
- 4. Sliding doors added on detail elevation drawing for GD02
- 5. Sunroom and porch omitted together with door GD07
- GD08 now repositioned to end of extension and with boiler room now renamed as porch.
 GW20 added at location of porch.
- 7. Detail drawing added for situations where there is a window in line with back of the masonry wall and stable doors fixed at the outside wall face. I have proposed simple 'farm' type hardware to the stable doors and sliding doors.
- 8. Elevations and plans revised to suit the above. GD 06 retained as external back door to Hall.

It looks from photos as though all of the original barn and stable door pin hinges have been lost over time so we have drawn new frames for stable doors with pin hinges and straps fixed to timber frames. That would mean two timber frames in those openings with the window at the back and the stable door at the outside face of the walls as drawn.

An alternative would be to hang them on pin hinges built into the masonry walls as the original ones were and not onto a new frame inside the opening. The tricky thing with built in hinges would be to get them accurately in alignment so that the stable doors hang plumb. Photo of the alterative built in pin hinge attached for information. We await your feedback and thoughts on this specific point.

I trust it will be appreciated that our client has made significant compromises in this set of revisions, which go beyond those we discussed as being acceptable?

Our client would like to understand the timescale and decision making route that will be followed -do we need to go to committee, and if so when might that be?

As discussed in previous e-mails, the 4 dangerous chimney pots are being replaced as works of

urgent repair.





GW02 SLIDING DOORS TYPICAL HARDWARE




