Hi Jill,

Thanks for this.

We have a significant number of reptile records for this area of the moor. As the work is likely to be carried out in winter when reptiles are dormant, the applicant should ensure that no potential hibernacula such as piles of brash or stones are disturbed throughout the construction phase of the works – both on the work site and along the access route to it.

Regarding the impact on the SAC/SPA, I have assessed whether a HRA would be required for the proposals and assert that;

- the proposal is not necessary for the management of the European site
- that the proposal is unlikely to have a significant effect on any European site, and can therefore be screened out from any requirement for further assessment

Natural England is a non-departmental public body. Our statutory purpose is to ensure that the natural environment is conserved, enhanced, and managed for the benefit of present and future generations, thereby contributing to sustainable development.

#### SUMMARY OF NATURAL ENGLAND'S ADVICE

#### **NO OBJECTION**

Based on the plans submitted, Natural England considers that the proposed development will not have significant adverse impacts on designated sites North York Moors Special Area of Conservation, Special Protection Area and Site of Special Scientific Interest and has no objection.

Natural England's advice on other natural environment issues is set out below.

# European sites – North York Moors Special Area of Conservation (SAC) and Special Protection Area (SPA)

The consultation documents provided by your authority do not include information to demonstrate that the requirements of Regulations 63 and 64 of the Habitats Regulations have been considered by your authority, i.e. the consultation does not include a Habitats Regulations Assessment.

In advising your authority on the requirements relating to Habitats Regulations Assessment, and to assist you in screening for the likelihood of significant effects, based on the additional information provided, Natural England offers the following advice:

- the proposal is not necessary for the management of the European sites
- that the proposal is unlikely to have a significant effect on any European sites, and can therefore be screened out from any requirement for further assessment

When recording your HRA we recommend you refer to the following information to justify your conclusions regarding the likelihood of significant effects.

The installation of a 2 metre extension of the existing boardwalk and a 4m staircase is very small scale and should be beneficial as it will reduce habitat erosion and decrease the number of desire lines in the area.

#### **North York Moors Site of Special Scientific Interest**

Based on the plans submitted, Natural England considers that the proposed development will not damage or destroy the interest features for which the site has been notified and has no objection.

#### **Protected Landscapes**

This application falls within the North York Moors National Park. However, owing to the nature and scale of the development, Natural England does not believe that it is likely to impact on the purposes of designation or special qualities of the National Park. We would advise that the proposal is determined in line with relevant NPPF and development plan policies, landscape and visual impacts are minimised as far as possible and landscape advice is obtained from the National Park landscape advisor.
