Details of the pre-application advice received

Pre-application advice was sought from Mr Edward Freedman, of the Building Conservation Team via email (26th April 2017) on temporary repairs to the timber posts using stainless steel straps. Mr Freedman indicated that a Listed Building Consent application would not be required for any temporary repairs. Since this, proposals have developed resulting in a longer term solution including the replacement of sections of each post with galvanised steel sections. As this is no longer a temporary repair it is anticipated that a Listed Building Consent application is now required.
