Condition 10 covers more than we'd asked for! The report dated Feb 11 we've already received probably covers the condition satisfactorily, other than the enhancement Sara suggested:

"Presumably planting and landscaping will be designed to add to the woodland feel of the site. Broadleaved trees, wildflower areas and even ponds could be very valuable for bats."

Broadleaved trees can be taken as read, but perhaps not wild flower areas. This should be heathy vegetation, given the location and a pond or two would be very good. However none of those is actually specified in the condition. What do you think?
