#### Introduction:

This document refers specifically to the above project and has been prepared to. demonstrate our commitment to comply as far as reasonably possible, with the requirements of:-Equality Act 2010 (which incorporates the disability Discrimination Act)

Part M of the Building Regulations

The North York moors National Park planning policies.

#### Site:

The site is located on the edge of the Goathland Moor, adjacent to Lancaster Cottages, Goathland, It is an area of land bounded by a mixture of dry stone wall, trees, hedges and post and rail fencing.

Access is via an existing track from the public highway.

The site has had a number of previous uses including keeping of livestock and vegetable growing.

#### Proposals:

It is proposed to develop the site for four Shepherds huts to provide contained self catering units with level access and a packaged F.W. Treatment plant.

There is evidence that access to the countryside has measurable benefits for mental and physical wellbeing.

A recent report from the institute of European Environmental Policy (IEEP) states that:-

### Access:

The location is serviced by public transport.

Vehicular access to the site will be via the existing track to the East of Lancaster cottages. Vehicle hardstanding areas will be provided within the site boundaries.

Level and/ or ramped access to individual units will be compliant with part M of the building regulations and all on site amenities will be designed to be wheelchair Accessible.

#### Design:

The proposed Shepherds huts will be of traditional design, using natural materials wherever possible, and will be adapted as necessary to allow wheelchair access.

The siting of the units will be arranged to minimise the visual impact and due regard for the immediate environment.

Additional screening will be provided by selective tree and shrub planting to ensure that the development blends in harmoniously with the immediate surroundings. Minor alterations will be made to the existing boundary features to improve security and give additional screening.
