Of all the photos you have submitted, the shaft with the mono-pitch roof looks the best. I appreciate that particular design wouldn't work in this instance but the gable doesn't look right. Have you considered plans with a flat roof – not sure that would work either but would be interested to see a plan. However, if the only engineering solution is as you propose, I think it unlikely that we would recommend the application for refusal.

I would advise you that an application for the proposed external timber clad lift is likely to be considered favourably, providing the external timber cladding is left to naturally silver.

However, I would request that the roof details be amended as the small gable would be out of keeping – the appearance would be improved with the incorporation of a cat-slide roof joining into the existing roof slope, or possibly a flat roof (if the height could be reduced to fall below the eaves).
