Thank you for forwarding the amphibian method statement. I note that the report concludes that the probability of Great crested newts or other amphibian species using the terrestrial habitat within the development footprint would be extremely low, but that mitigation measures have been proposed to ensure that no Great crested newts or other amphibian species are killed or injured within the development footprint in the unlikely event of individuals being present.

The mitigation measures in Section 6 of the report should be conditioned if the application is approved. I am very pleased that a hibernaculum is to be installed outside the development footprint which should ensure that future conditions for amphibians within the area are enhanced.
