Thank you very much for drawing my attention to this matter; from following the link to the plans, it would seem that Mr Fiddler is seeking permission to change the spec of the roof tiles on the proposed 'orangery' extension, on the basis that this will allow the 'orangery' to blend in with the existing building, and will diminish noise nuisance to neighbours.

The change of proposed roofing materials may well achieve both these ends, or it may not - I am not qualified to judge.

My concerns re the extension are primarily to do with the effects of building on unstable ground - as I have previously tried to raise with the planning authority and the local authority - and given that I have seen considerable alteration in the cliff top land at the foot (the immediate foot, now) of my garden, which is alongside the Vic land.

I also note that the fence which Mr Fiddler had erected at the sea-side edge of the car park (above sloping land) is now uneven and bowing outwards, as the land is clearly not stable enough to hold it upright - due to land movement.

I contend that the site should be revisited and reassessed, as conditions have altered and worsened since 2015 when the information was seemingly taken to inform the planning decision.

I am very unhappy that the intention to extend the Vic, which seemed to have faded away, is raising its head again - but I do appreciate that, as permission has been granted, the owner of the Vic can extend if he wishes to. I am dismayed that the voices of concerned locals have counted for so little.

I do appreciate your having informed me, thank you.
