Condition 72 relates to highways work so I don't think that covers all the retained woodland pertinent to phase 2?

Although I haven't scrutinised the Tree Protection Plan and the Arboricultural Method Statement in sufficient detail to be able to confirm it meets our requirements. I can say that it appears that sufficient protective fencing is proposed on the plan to exclude activity in the retained woodlands. Therefore I would advise that providing the applicant can confirm that the paragraph below is revised to relate to Condition 70 as well, condition 73 could be partially discharged (with caveats) as you suggest.
