Planning consultation: installation of doors and erection of balcony, together with change of use of land and erection of decking to create enlarged seating area
Location: The Fish Box, New Road, Bank Top, Robin Hoods Bay

Thank you for your consultation on the above dated 25 May 2017 which was received by Natural England on 25 May 2017.

Natural England is a non-departmental public body. Our statutory purpose is to ensure that the natural environment is conserved, enhanced, and managed for the benefit of present and future generations, thereby contributing to sustainable development.

The Wildlife and Countryside Act 1981 (as amended)
The Conservation of Habitats and Species Regulations 2010 (as amended)

Natural England's comments in relation to this application are provided in the following sections.

Statutory nature conservation sites – no objection

Natural England has assessed this application using the Impact Risk Zones data (IRZs) and is satisfied that the proposed development being carried out in strict accordance with the details of the application, as submitted, will not damage or destroy the interest features for which Robin Hoods Bay: Maw Wyke To Beast Cliff SSSI has been notified. We therefore advise your authority that this SSSI does not represent a constraint in determining this application. Should the details of this application change, Natural England draws your attention to Section 28(l) of the Wildlife and Countryside Act 1981 (as amended), requiring your authority to re-consult Natural England.

England Coast Path

Natural England has a duty to provide coastal access on foot around the whole of the English coast and is aiming to complete this by 2020. We would be supportive of any planning application that includes provision for the coastal access trail

Protected species

We have not assessed this application and associated documents for impacts on protected species.

Local sites

Our SSSI Impact Risk Zones are a GIS dataset designed to be used during the planning application validation process to help local planning authorities decide when to consult Natural England on developments likely to affect a SSSI.
