We are proposing to change 4 of the 5 office facilities on the first floor of the workshops building in the Courtyard in Dalby Forest, to ancillary short term accommodation linked to the workshops spaces on the ground floor. Office 5 is still occupied as an office.
 In 2017, we will be piloting a new approach to Arts in Dalby Forest. A grant from the Arts Council is helping us to work with the charity Crescent Arts, who use high quality artists to develop the skills of local artists and form partnerships. These artists will stay in temporary accommodation in what is currently office 1, 2, 3, and 4 above the workshops which they will use to host activities to train and educate local artists as well as visitors, to exhibit art and to work and develop a programme of arts activities in Dalby - for a number of weeks at any one time.
 The only physical alteration to the building will be to change a toilet unit upstairs in to a shower unit.
