Hi Rob

I think as a result of last week's meeting we have further clarity on the attenuation measures proposed at the site, and their commitment to comply with planning and noise conditions. I feel that any future submissions should be more specific on the measures that they have tried to adopt and those that are likely to be tweaked onsite. This would give us greater confidence that best practicable means was being used. I note that residents' concerns regarding noise are minimal and welcome the public relations measures to keep the residents informed appear to be effective.

On the basis of the above and the already submitted report I have no objections to the discharge of the noise and vibration conditions for phase 4.

I would however like to note that the soon to be submitted environmental permit application to the Environment Agency will need to contain noise control measures for the permitted activities.
