On behalf of the Hawk and Owl Trust (Registered Charity No. 1058565) I am applying for planning permission to retain the existing wooden boardwalk sections of the Jagger Howe Nature Trail. Approval was previously given for this development in 2012 (NYM/2011/0746/FYL) for a period of 5 years, which has now elapsed. The boardwalk sections were part-funded through the NYMNPA's LEADER programme, and their location was as recommended by the Senior Ecologist at NYMNPA. The Nature Trail remains an integral part of the Trust's outreach and education programme, and the boardwalk sections permit safe public access to the moorland whilst preventing damage to the flora, fauna and ground in the surrounding area. The Trust does not propose to alter the original length or locations of the boardwalks, and there are no substantive changes to the original application.
