Site is in a Conservation Area and consists of a Grade II Listed dwelling (with details of listing set out in the Heritage Statement) and adjoining outbuildings built late on within the curtilage of the main dwelling. The site is located at the edge of the village centre backing onto agricultural land and the proposed works to the outbuildings are not readily visible to the public due to the lie of the land and adjacent buildings. The frontage to the highway is in the applicant's ownership. The original dwelling house retains its original structural form with predominantly maintenance works only being undertaken to the roof, drainage and pointing, save for the extension and alteration of the existing rear extension. The outbuildings are not of the same quality as the main dwelling in either design or construction and require structural works to bring them back into a sustainable use. The site is self contained all in the ownership of the applicant and the proposed works do not impinge on either of the next door neighbours.
