Hi Hilary,

I met Ged Lyth at the Hare and Hounds last week with the client just to look at options for the car parking layout.

Ged confirmed the best way to approach this would be to make sure we can create an additional 9 spaces. In that respect I attach a copy of drawing D11168-11A which shows an existing (presumed) layout along with a formal proposed layout.

The existing situation is very informal, no lines are painted so parking is Ad Hoc. The space is unlikely to make as good use as is shown on the 'existing' layout.

Our client will make good the areas of poorly finished tarmac before making Bays on the ground to direct customers and make best use of the space available which is ample.

Attached are a few pictures showing the current situation and the obvious room for improvement.

The spaces are created in the following locations:-

- Where the existing Freezer store is situated
- Immediately to the right of the Entrance as you come in to the site, behind the existing boundary hedge
- Immediately to the left of the entrance. Due to lack of markings this is currently treated as part of the access.

• The drive through the site giving poor but direct access to the A171 is to be sealed shut. The space created will be used to allow more parking and a space for turning

I hope these details are helpful to your consideration of the scheme and I look forward to your reply in the near future.


