This proposal is for the installation of a sculpture by Turner Prize winning artist, Rachel Whiteread, on the location of a previous WWI and WWII camp, which housed Nissen Huts in Low Dalby, in Dalby Forest. The sculpture is a concrete structure made of concrete corrugated panels, created in the shape of a Nissen Hut, to interpret and celebrate the history of the site.
This sculpture represents the end of WWI and the establishment of the Forestry Commission in 1919.
It will be placed on a platform on the side of the bank on the eastern side of Ellerburn trail, nestled within the trees. Access paths leading to the sculpture will be wheelchair accessible and will blend into the landscape with surrounding vegetation. The retaining wall will also be covered in vegetation to blend into the landscape.
