This is a full planning application under The Town and Country Planning Act 1990 and the Planning (Listed Buildings and Conservation Areas) Act 1990. It is also a notice in accordance with the electronic communications code as amended.

The Emergency Services currently use a mobile radio system (Airwave) to communicate but this needs replacement as the technology cannot deliver broadband data services. The Emergency Services Mobile Communications Programme (ESMCP) is the Home Office led programme responsible for replacing Airwave. It aims to provide an integrated voice and broadband data communications service for the Emergency Services (3ES: Police, Fire & Rescue and Ambulance Services). This Emergency Services Network (ESN) has initially been deployed by enhancing an existing commercial network configured to give the 3ES priority over other users. This proposal, as a component of the ESN, is for the Extended Area Services (EAS) which is to provide additional infrastructure to extend the ESN into primarily remote and commercially unviable areas where little or no mobile network coverage exists. This proposal forms part of the nation's Critical National Infrastructure.
