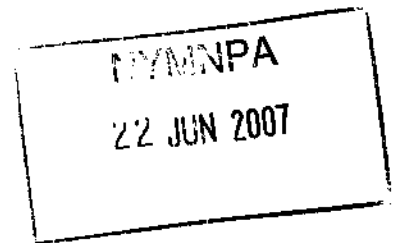
- (a) for consent under section 37 of the Electricity Act 1989 to install or keep installed an electric line above ground.
- (b) for a direction under SECTION 90(2) OF THE TOWN & COUNTRY PLANNING ACT 1990 that planning permission for the proposed development be deemed to be granted.

In order to improve the electricity supplies in the Sleights area it will be necessary for Bethell Power Services Ltd on behalf of NEDL to rebuild the existing overhead powerlines and replace associated equipment which has reached the end of its service life.

The lines will be rebuilt in the existing locations with aerial bunched conductor (ABC) and the sections to be replaced totaling 585 metres are shown in red on plan 9815081/2 whilst the section to be dismantled is shown in blue.

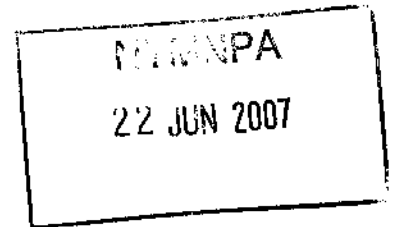
