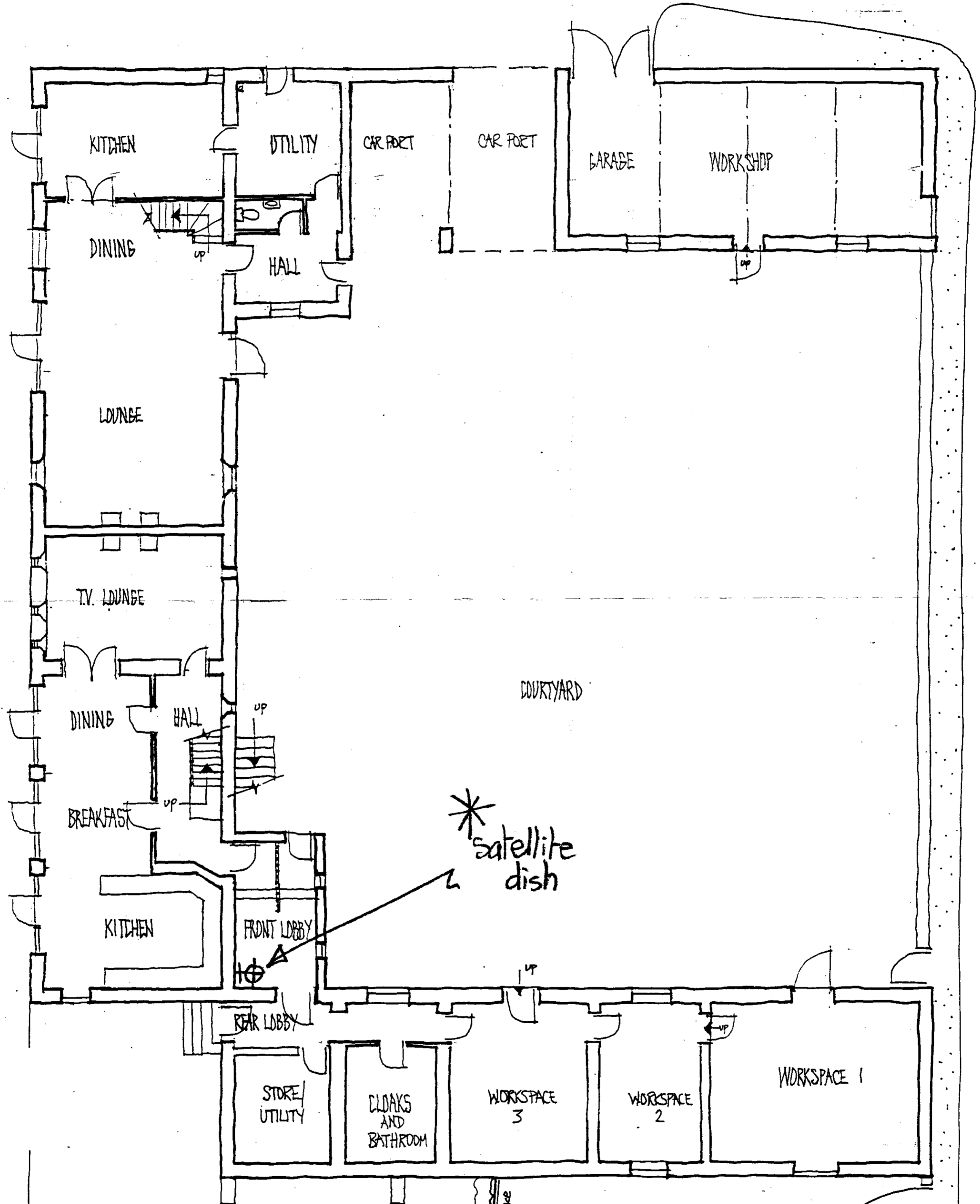

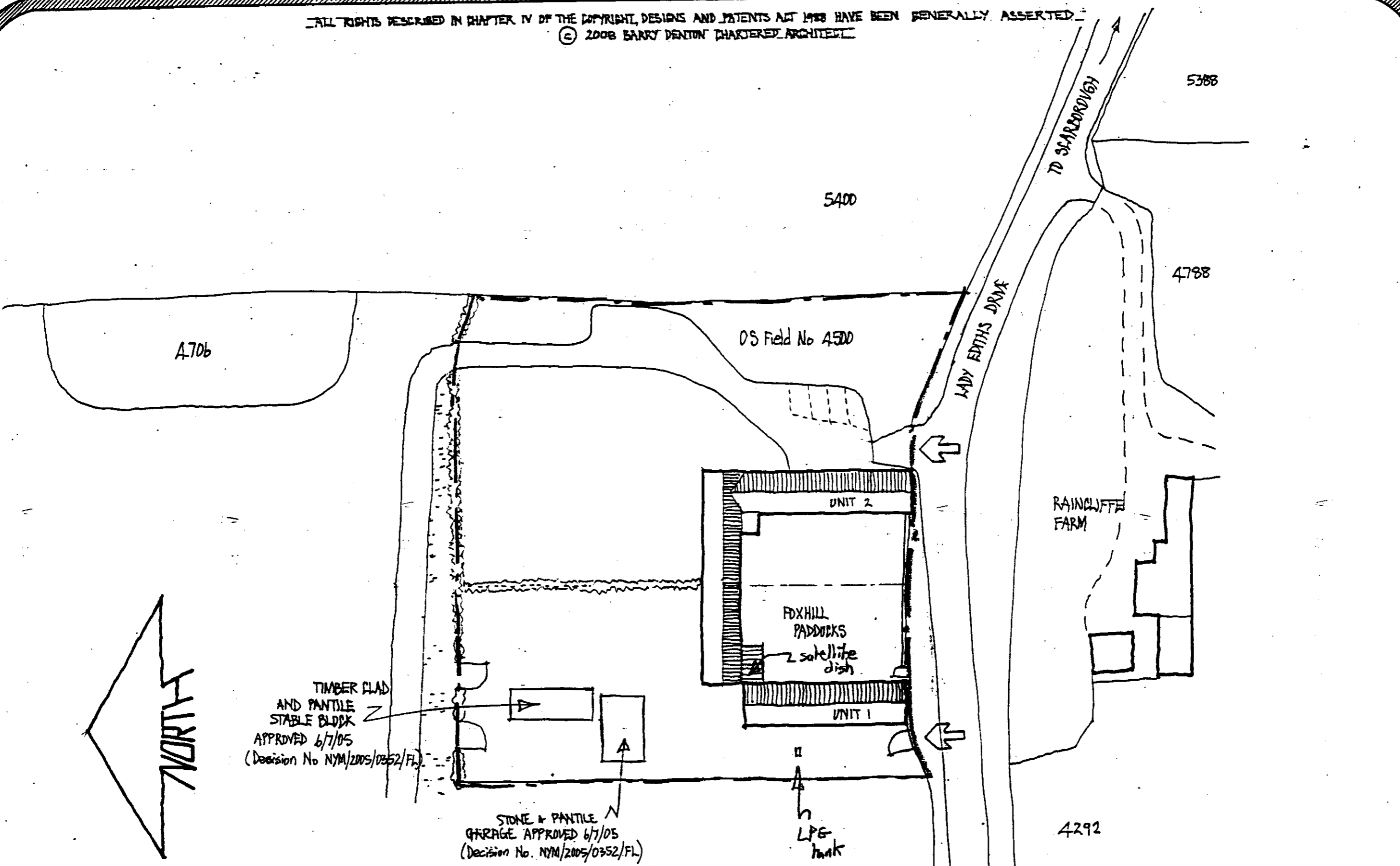

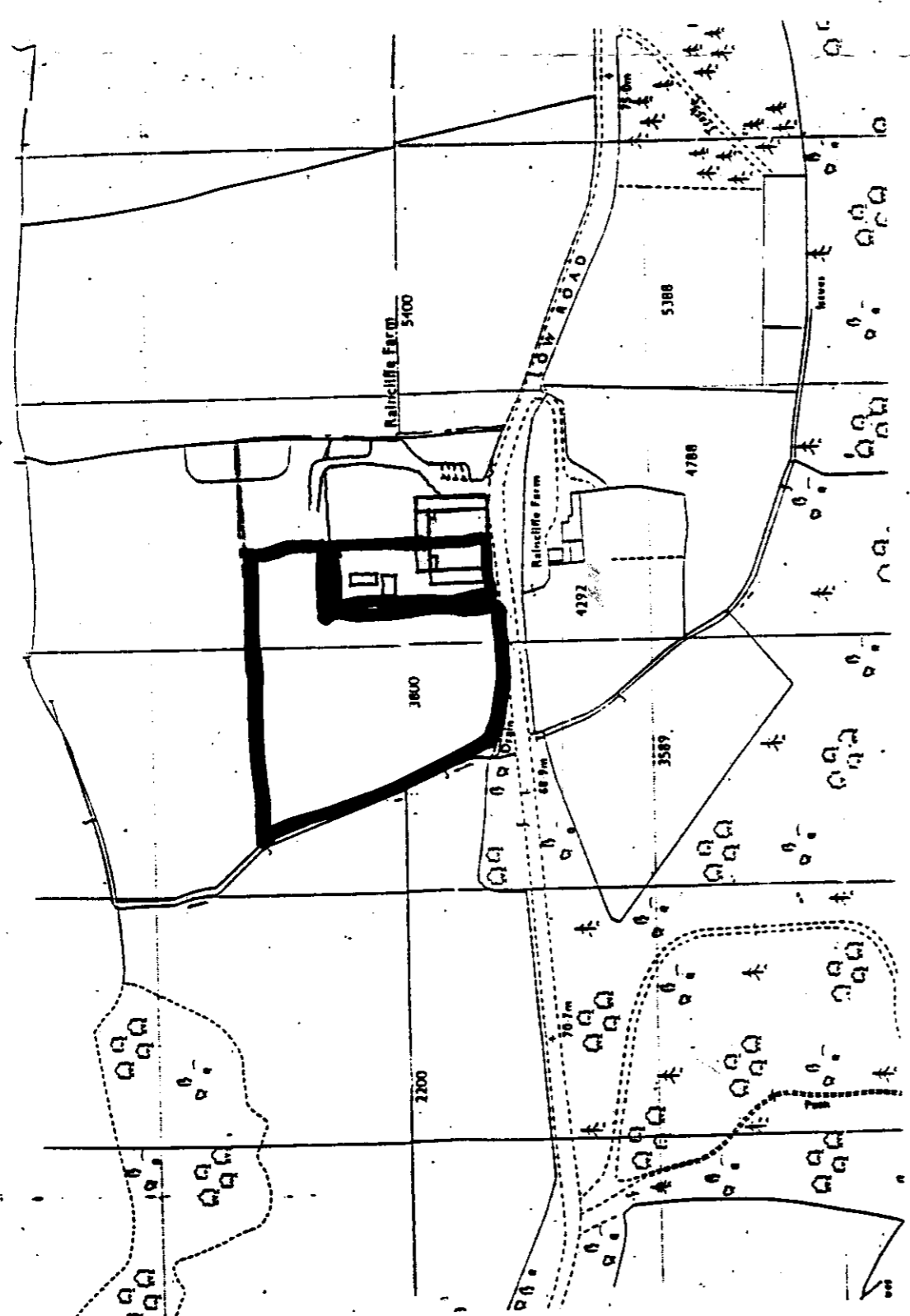

AT FOXHILL PADDOCKS, LOW ROAD, THROXENBY, SCARBOROUGH,

CONTEXT

This stone and pantile residence was originally part of a farm fold yard which was divided into two parts and converted to residential use approximately four years ago (under decision numbers NYM/2004/0396/FL and NYM/2004/0397/LB).

This application is to install a satellite dish and an LPG tank.

AMOUNT OF DEVELOPMENT

Satellite dish and LPG tank.

APPEARANCE

The satellite dish is wall mounted, on an internal corner of the courtyard. The dark grey finished dish is installed below eaves level and thus, viewed against a background of stonework.

The LPG tank is sited to the west of the range of conversions and is hidden from view by a fence and hedge.

ACCESS

Level access will be unaltered.

SUMMARY

The character and appearance of the property and of the North Yorkshire Moors National Park, will be unaltered by the proposals.
