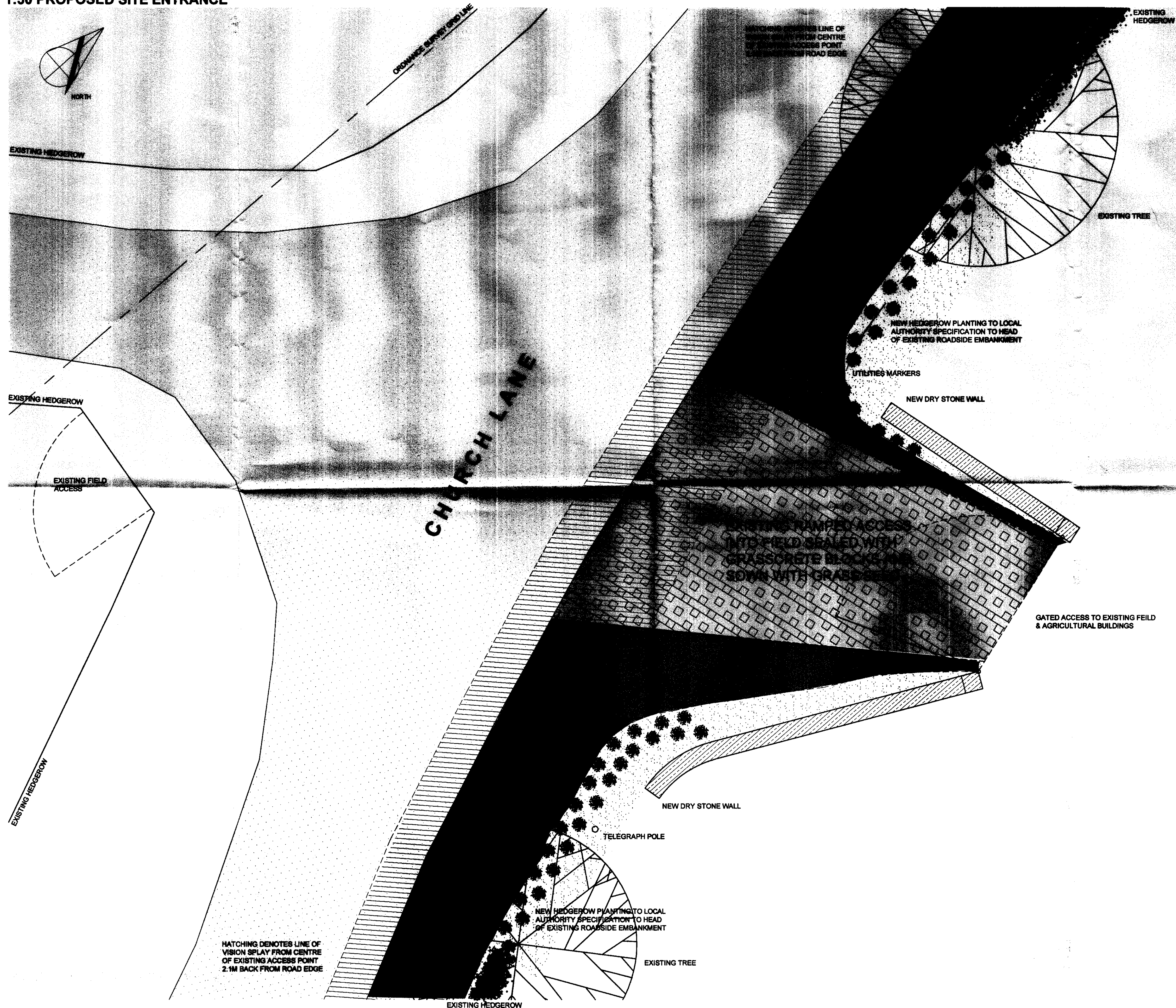

THE PROPOSED AMENDMENTS TO THE EXISTING FIELD ENTRANCE ARE TO CREATE A SAFE AND PRACTICAL ENTRANCE FOR THE UTILISATION OF THE EXISTING STABLES AND PADDOCKS.

IT IS PROPOSED THAT THE FIELD WILL BE SUB-DIVIDED INTO PADDOCKS WITH HORSES AND OTHER LIVESTOCK BEING KEPT ON THE AGRICULTURAL HOLDING.

TO IMPLEMENT THE WORKS THE EXISTING RAMPED ACCESS INTO THE FIELD HAS BEEN GRADED BACK TO PROVIDE A SAFE GRADIENT WITH VEHICLES ABLE TO PULL INTO THE ENTRANCE WHILST THE GATE IS OPENED. SIMILARLY, VEHICLES CAN THEN LEAVE THE FIELD AND SECURE THE GATE WITHOUT HINDERING THE TRAFFIC ON THE ADJACENT ROAD.

THE ENTRANCE WILL BE FRAMED WITH A TRADITIONAL DRY STONE WALL (LESS THAN 1 METRE IN HEIGHT). THIS WILL FOLLOW THE LINE OF THE RAMPED ACCESS INTO THE FIELD WITH THE ADJACENT EMBANKMENTS SOWN WITH GRASS SEED TO CREATE A VERGE IN KEEPING WITH THE SURROUNDING AREA.

THE FIELD BOUNDARY IMMEDIATELY ADJACENT TO CHURCH LANE HAS AN EXISTING HEDGEROW WHICH WILL BE REINSTATED TO THE CORRECT SPECIES AND DENSITY OF PLANTING UNDER THE DIRECTION OF THE LOCAL AUTHORITY. THE HEDGEROW WILL BE PLANTED TO OVERLAP THE ENDS OF THE NEW DRYSTONE WALL, THEREBY LIMITING THE IMPACT OF THE NEW WALLS ON THE VIEWS FROM THE SURROUNDING AREA.

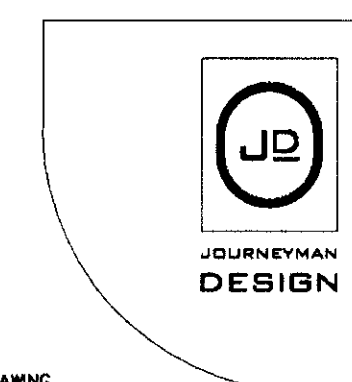

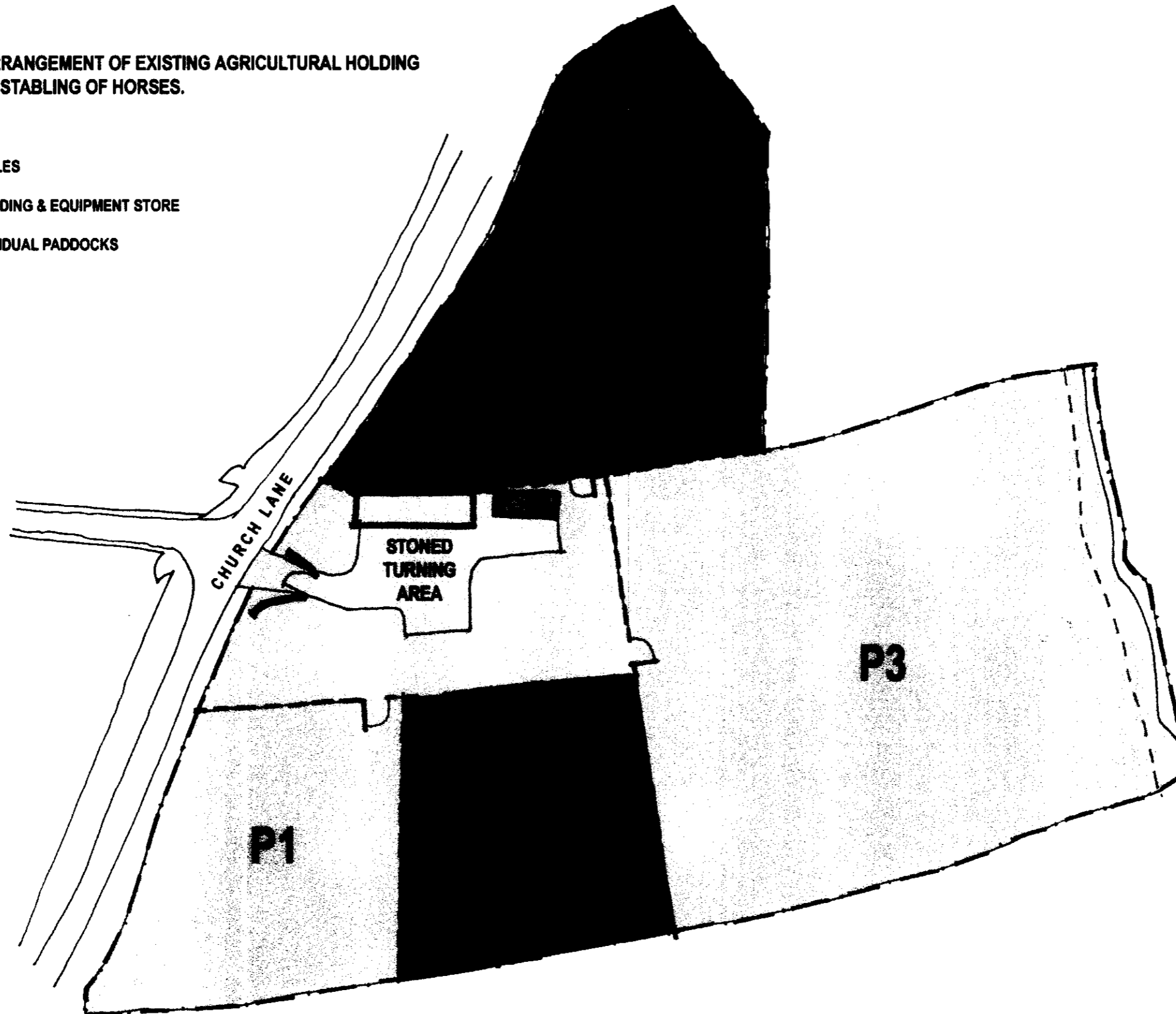
**SCHEMATIC ARRANGEMENT OF EXISTING AGRICULTURAL HOLDING

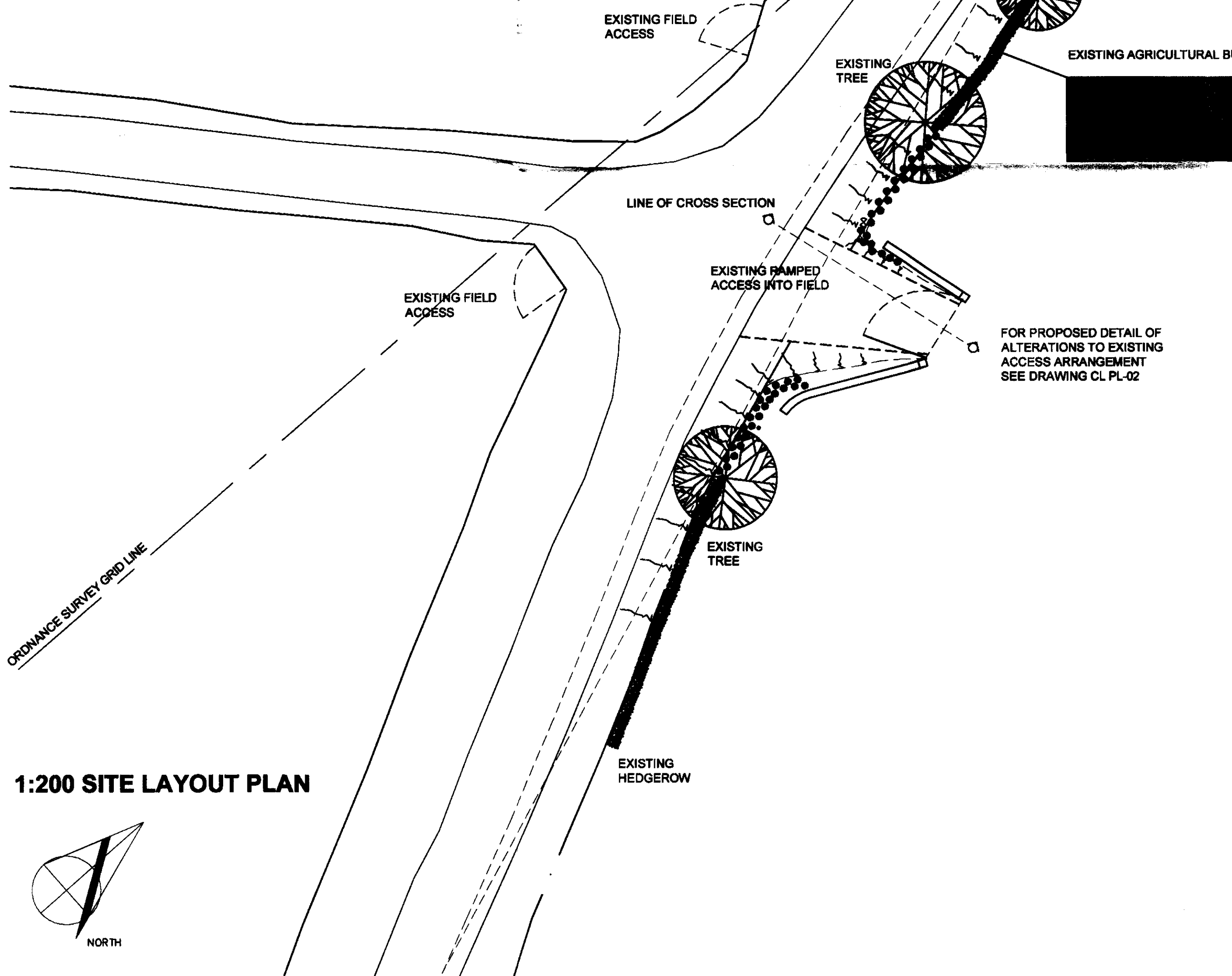

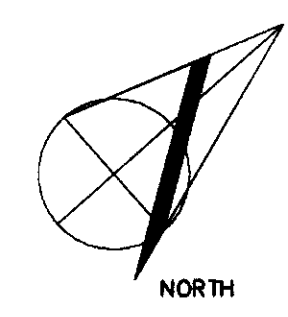

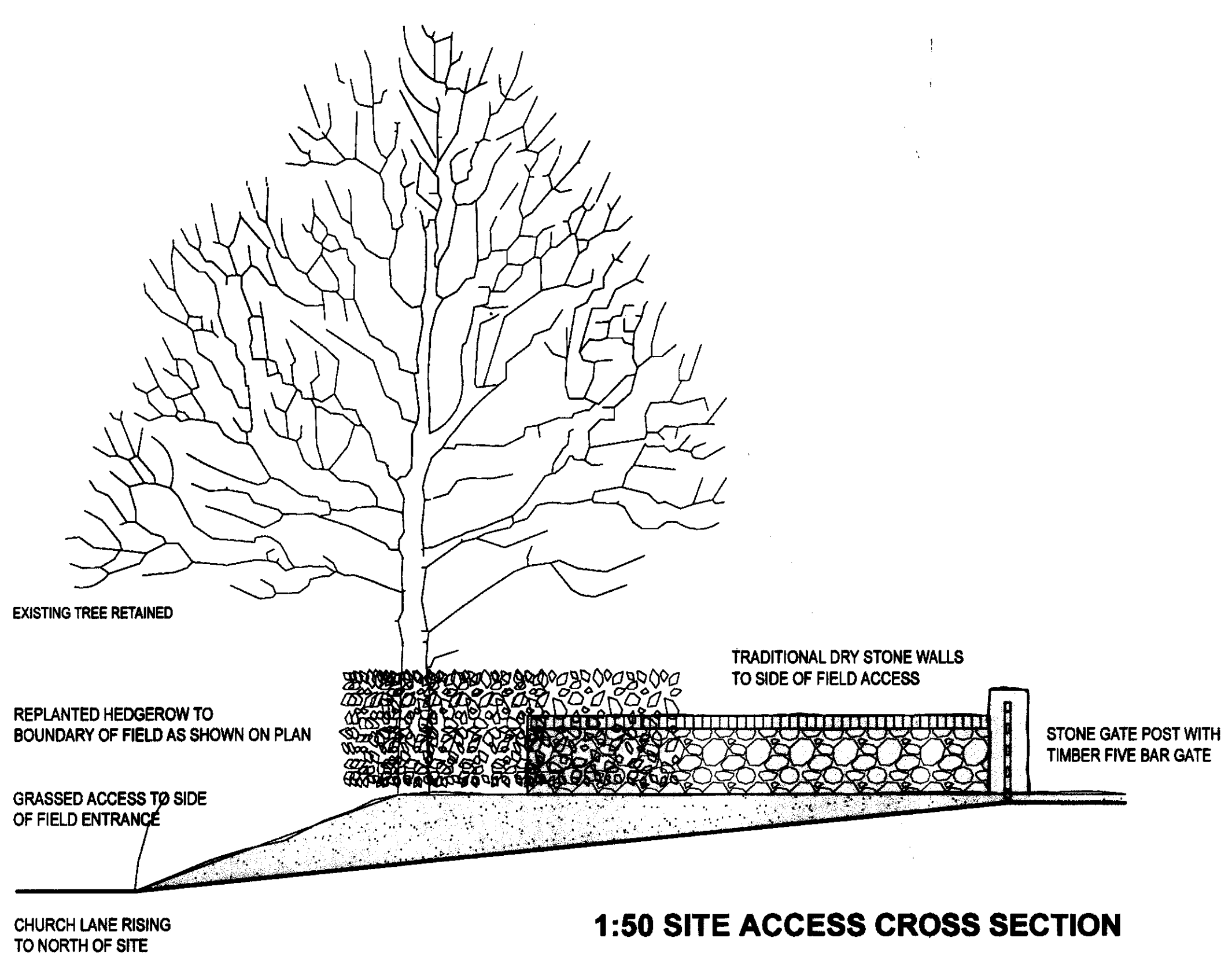
1:1250 SITE LOCATION PLAN

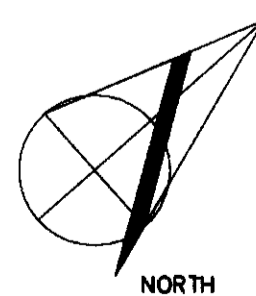

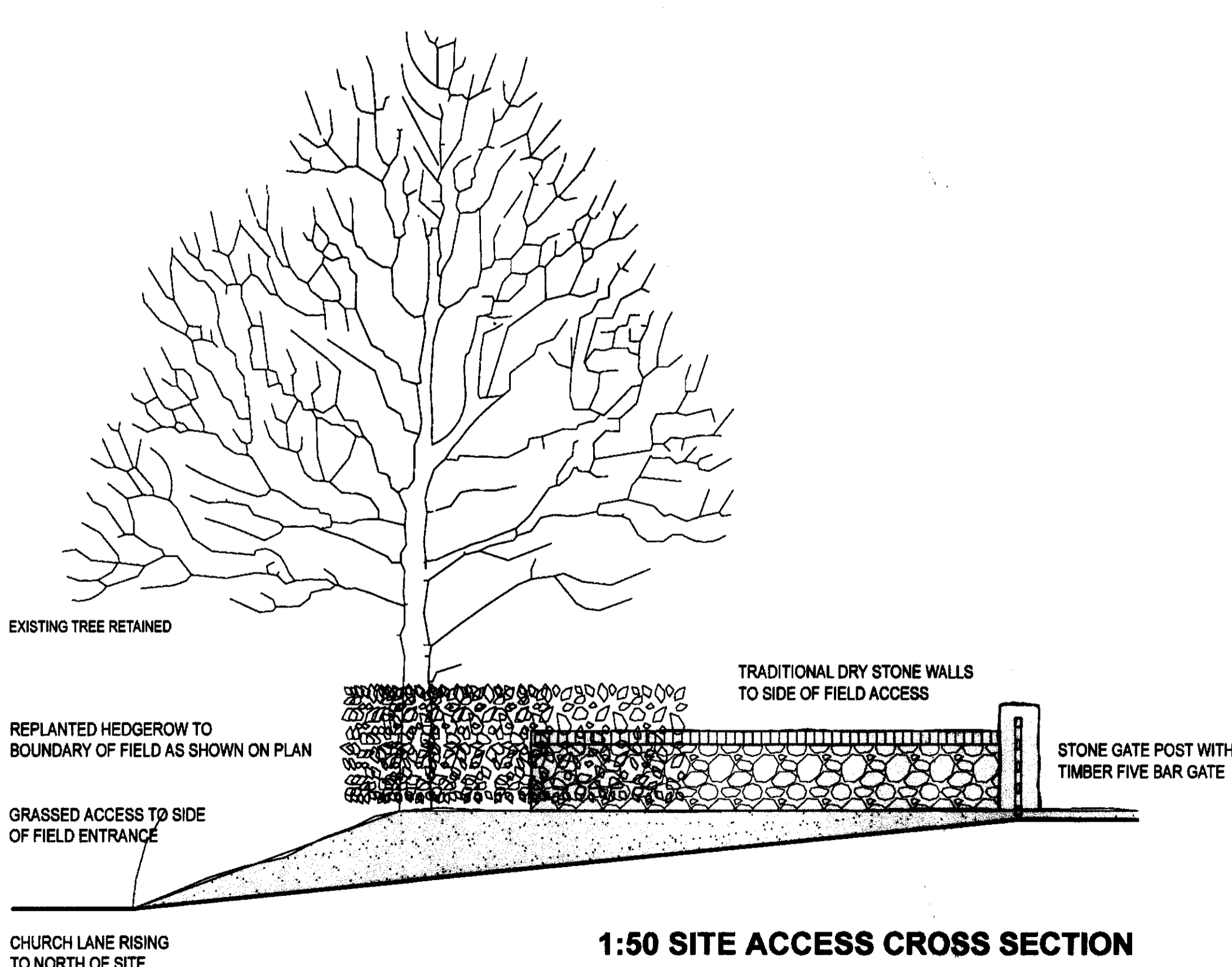
1:1250 SITE LOCATION PLAN

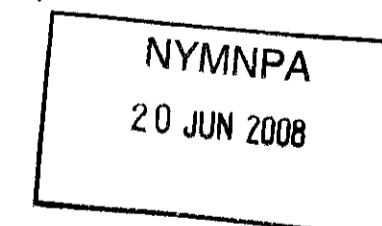

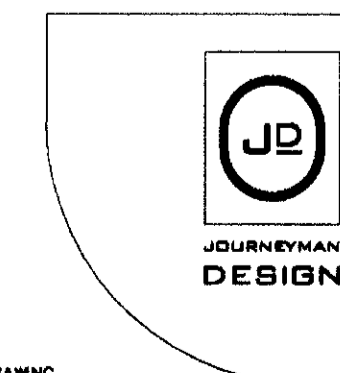

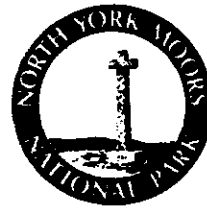
