The existing fencing around this important mast site is inadequate for security purposes and a new, robust security fence with gates is required.

We acknowledge that the site is situated in a National Park and that any proposed structures need to be as intrusive to the surrounding areas as possible.

Our proposal is to erect a standard palisade fence, powder coated green, around the perimeter of the site.

The existing dry-stone walling and gates to the front of the site will be kept in place and the new fence placed 1 metre behind. The low-level timber post and rail fence to the side and rear of the site will be removed. For security purposes the height of the fence will be 2.4m.

The access to the site will not be altered with a pair of gates placed directly behind the existing gate opening.

The new fence will be coloured green to help it blend into its surroundings.

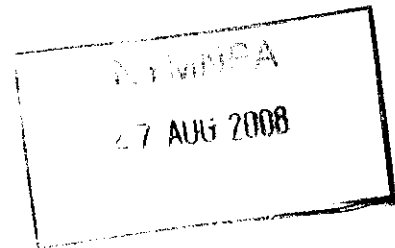

**Proposed Security Fence: Ravenscar Mast, Ravenscar**

We are hoping for approval to erect a 2.4m high palisade fence for security purposes around our radio mast site at Ravenscar.

Due to several cases of trespassing and vandalism to the various unmanned radio mast sites we have across North Yorkshire it is essential that we protect our property from further damage as best we can.

We acknowledge the fact that a number of these sites are in conservation areas, therefore we intend to limit the height of the fences to 2.4m, powder coat them green to blend into their surroundings and keep in place any existing dry-stone walling/fencing.

Although not completely protecting the site from any determined trespasser, the fencing will deter passing vandals and thieves who might cause expensive and ultimately dangerous damage to the equipment (e.g. removing copper earthing protection).

Maintaining the security of these sites is of vital importance to the functioning of North Yorkshire Police Force.

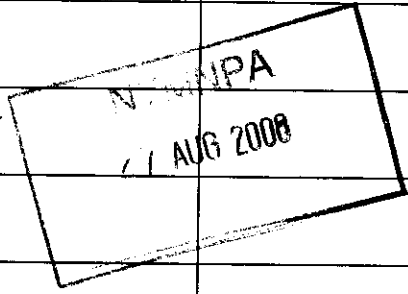
