- (a) for consent under section 37 of the Electricity Act 1989 to install or keep installed an electric line above ground.
- (b) for a direction under SECTION 90(2) OF THE TOWN & COUNTRY PLANNING ACT 1990 that planning permission for the proposed development be deemed to be granted.

As part of the ongoing improvement works in the Grosmont area, Bethell Power Services on behalf of NEDL propose to replace a number of sections of open wire electrical conductor in favour of Aerial Bunched conductor (see attached photographs).

I have enclosed copies of NEDL drawing number 9813724 showing coloured Red the existing overhead lines that are to be replaced with Aerial Bunched conductor. The sections of line have a total length of approximately 500 metres.

The above works would normally fall under our exemption regulations, however due to the sections of line being situated within the National park, full planning permission is required.

3. Particulars of the applicant's compliance with his duty under paragraph 1 of Schedule 9 to the Electricity Act 1989.

Due to the new conductor being in direct replacement for the existing electrical conductor (electric wires) it is not considered that there will be any impact upon the surrounding landscape.

ABC networks are considered more environmentally friendly, allowing conductors to be left in closer proximity to existing trees minimizing tree cutting and reducing requirement to fell amenity trees. The thicker conductor which can be more easily seen by birds helps to eradicate bird strikes without the need for fitting more visually obtrusive bird flight diverters. Studies have shown that owls and bats flying at night are better able to detect and avoid ABC networks.
