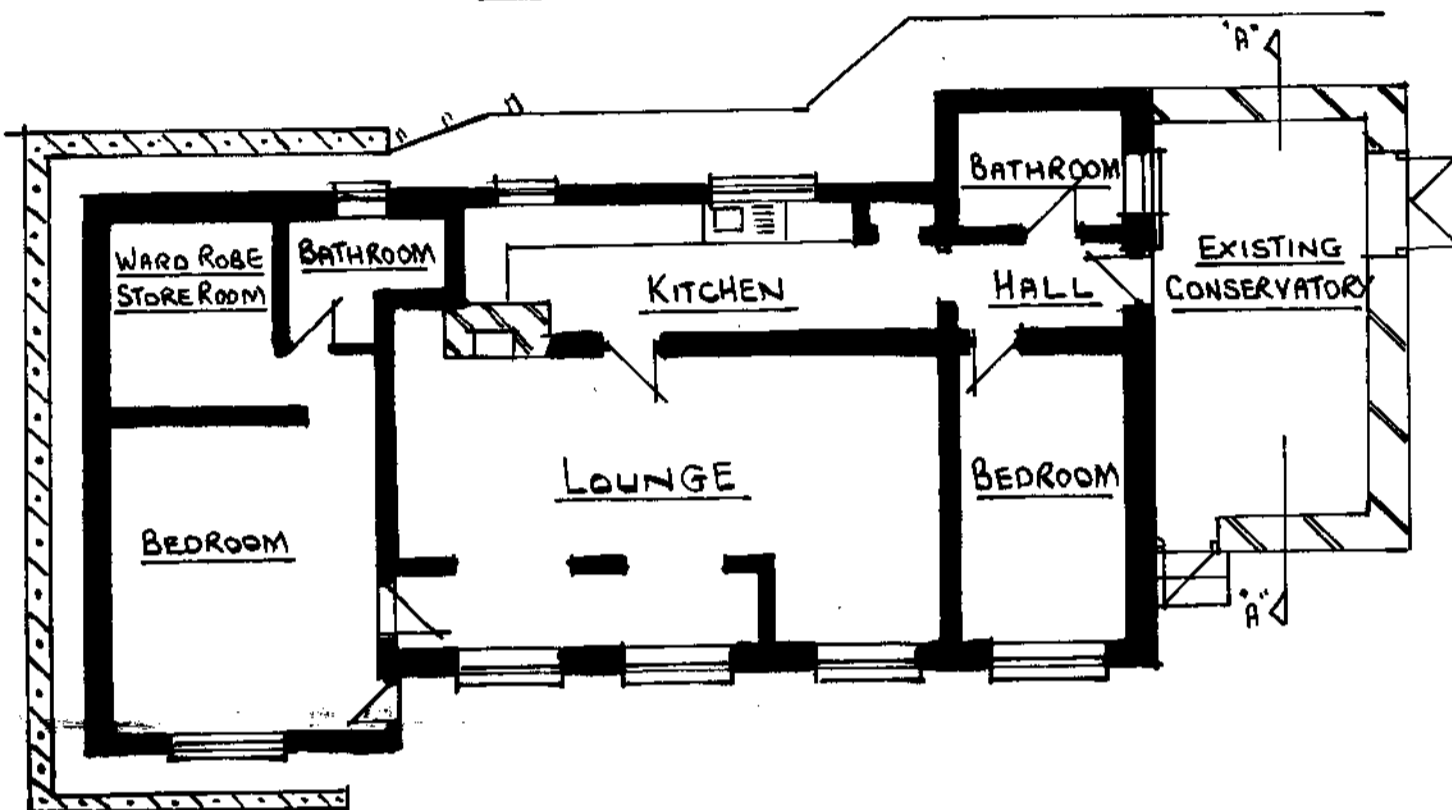

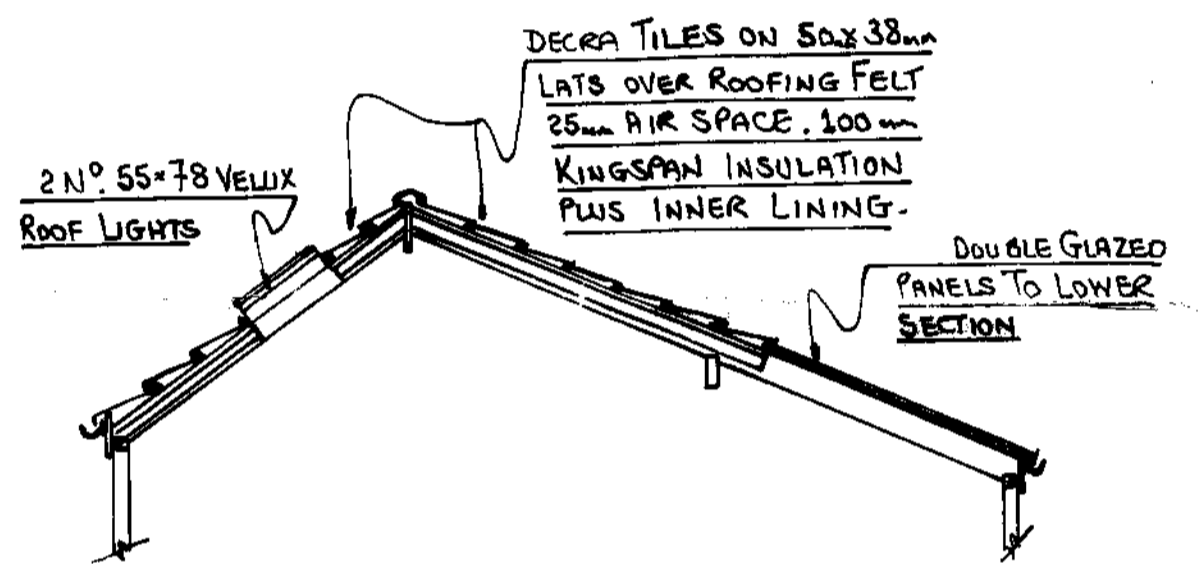
TYPICAL CROSS SECTION OF BOTH GARAGE & MOTORBIKE SHED SCALE 1/50



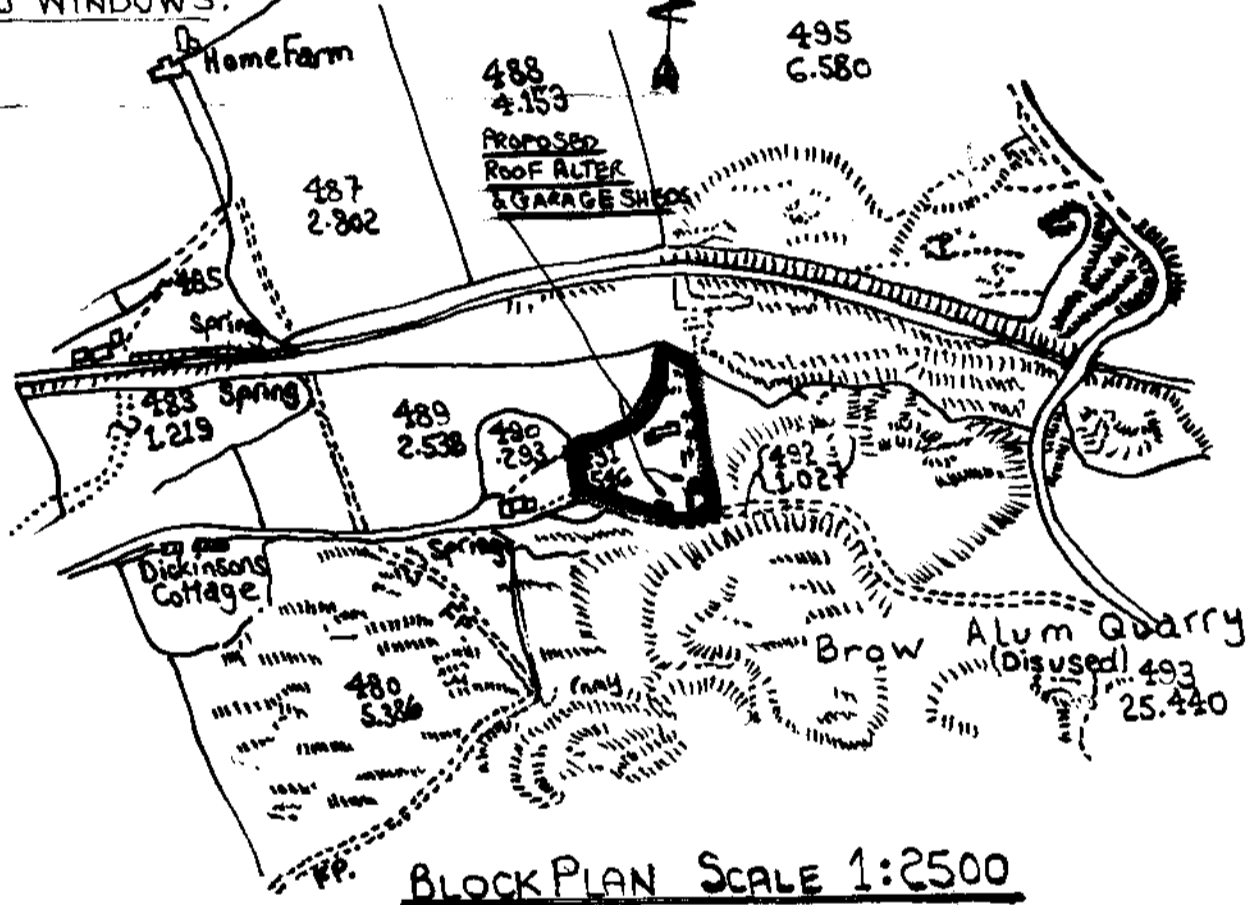
REAR ELEVATION SOUTH
