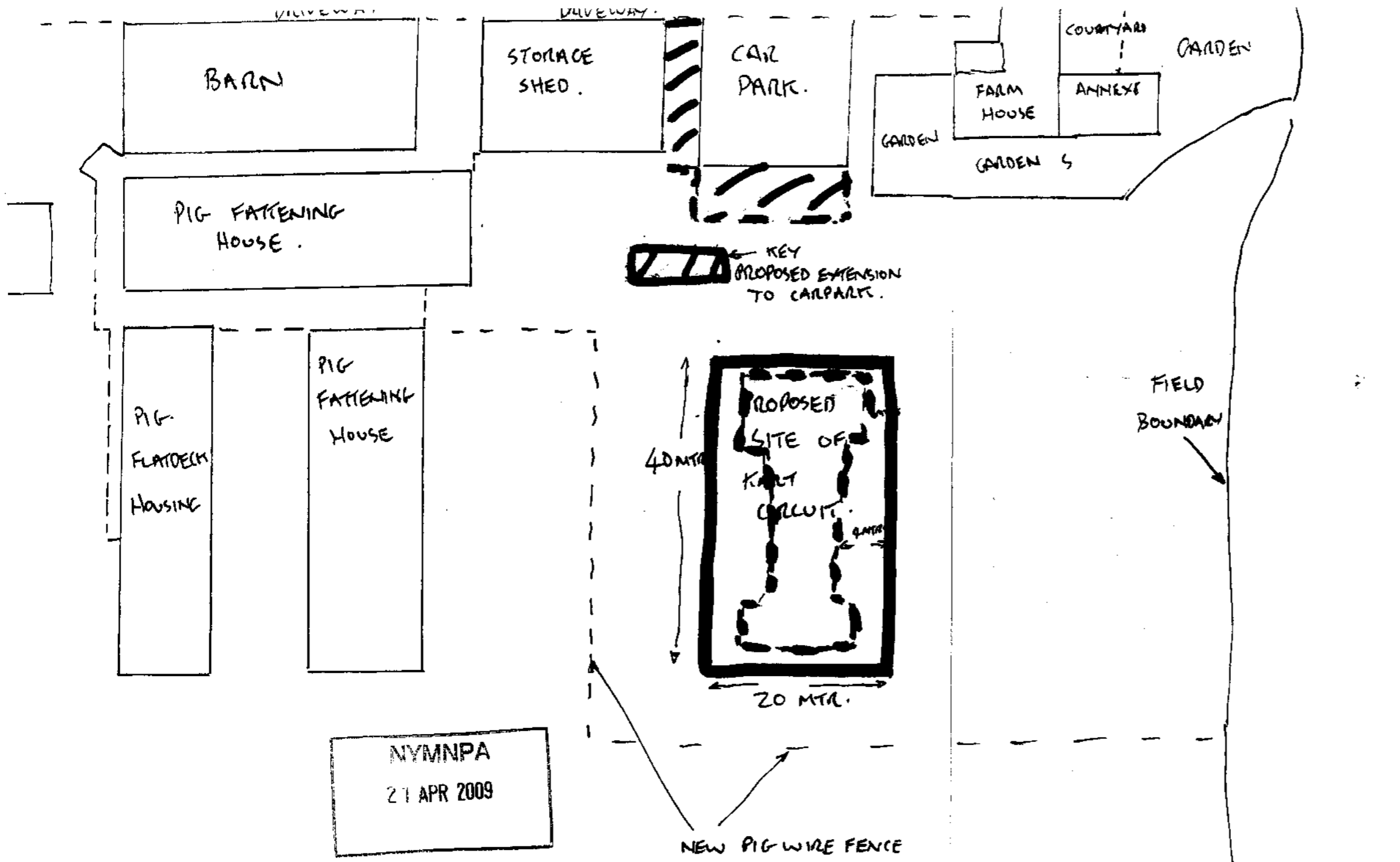
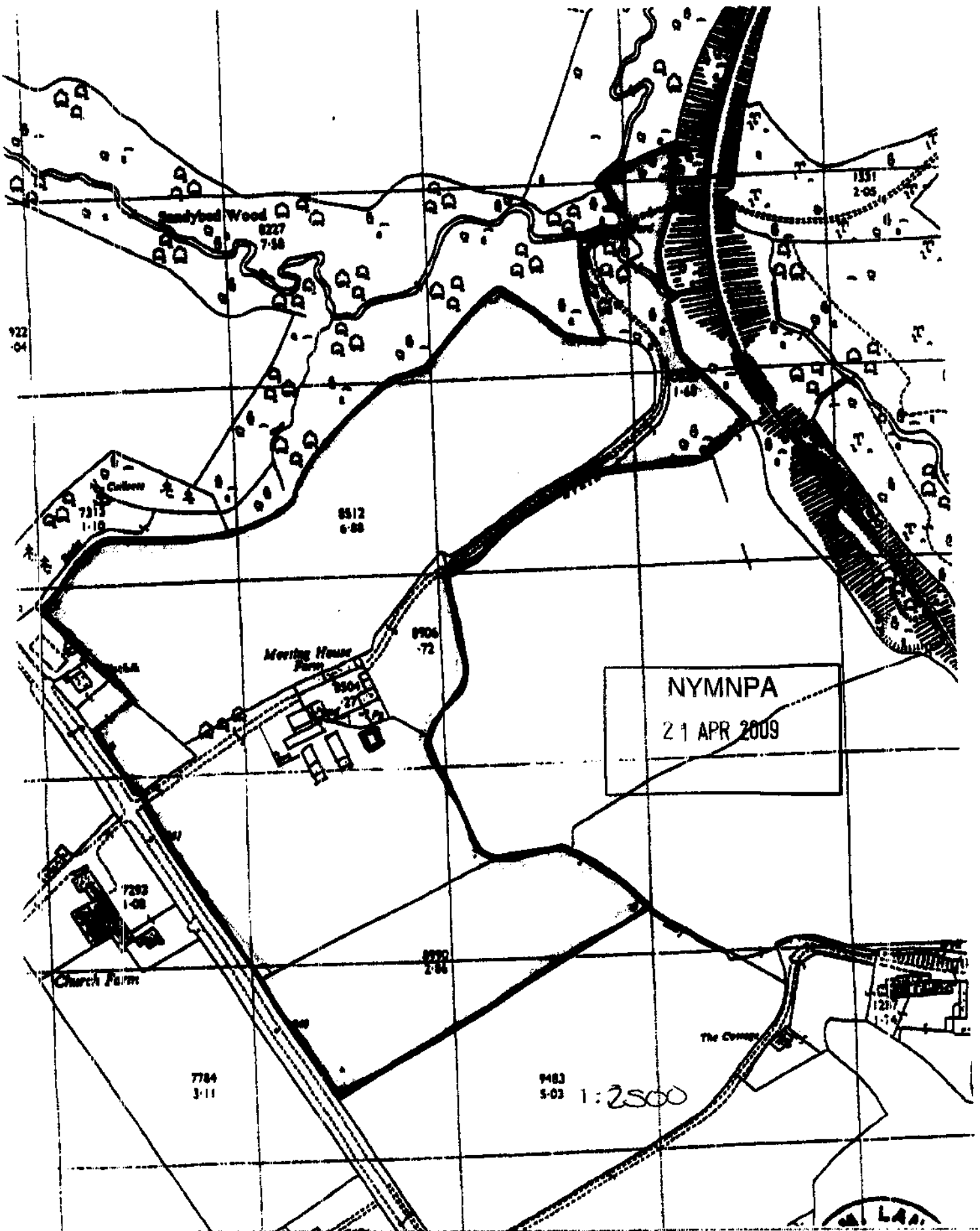

THE CONSTRUCTION OF PROPOSED CIRCUIT INVOLVES SLIGHTLY LEVELLING THE AREA AND RESEEDING WITH GRASS, AND THE LAYING OF PLASTIC MESH ONTO THE GRASS AND ALLOWING IT TO GROW THROUGH AND BE CUT SHORT. TO ALL INTENTS & PURPOSES THE CIRCUIT ~~WILL~~ WILL APPEAR JUST AS A GRASSFIELD. THE CIRCUIT WILL MEASURE 40 X 20 MTRS AND THE CIRCUIT WIDTH ALONG HALF THE 40 MTR LENGTH WILL BE 4 MTRS WIDE AND 2 MTRS ELSEWHERE. PLEASE FIND ENCLOSED A SAMPLE OF THE PLASTIC MESH WE WISH TO USE, AND LEAFLET EXPLAINING ITS USE.
