

In favour of affordable housing on this site?




Comments in favour

- Housing is desperately needed for youngsters in the area. This site would seem to be a good choice due to reasonably flat location and away from the chaos of the holiday areas of the village.
- Supported my only concern is that there is insufficient parking (should be 2 spaces per unit)
- In support but concerns about open spaces, which could encourage parking in undefined areas and therefore lead to disputes over

- Will make Crescent very busy with traffic and noise for residents in the area, especially the elderly
- Should not build near elderly residents. Nearby streets already congested with cars and noise. Every council property should have a driveway
- Over concentration of houses in Middlewood area already although I appreciate identification of sites is very difficult. Planning restrictions (occupancy) further complicates matters
- Strongly object because it would bring residents too close to my long established business of Touring/Tents and farm (150 cattle). Existing drainage not large enough to take extra drainage in times of high rainfall, drains already overflow and sewage mix runs down to Middlewood Farm. Also inappropriate because it joins 'old peoples bungalows'
