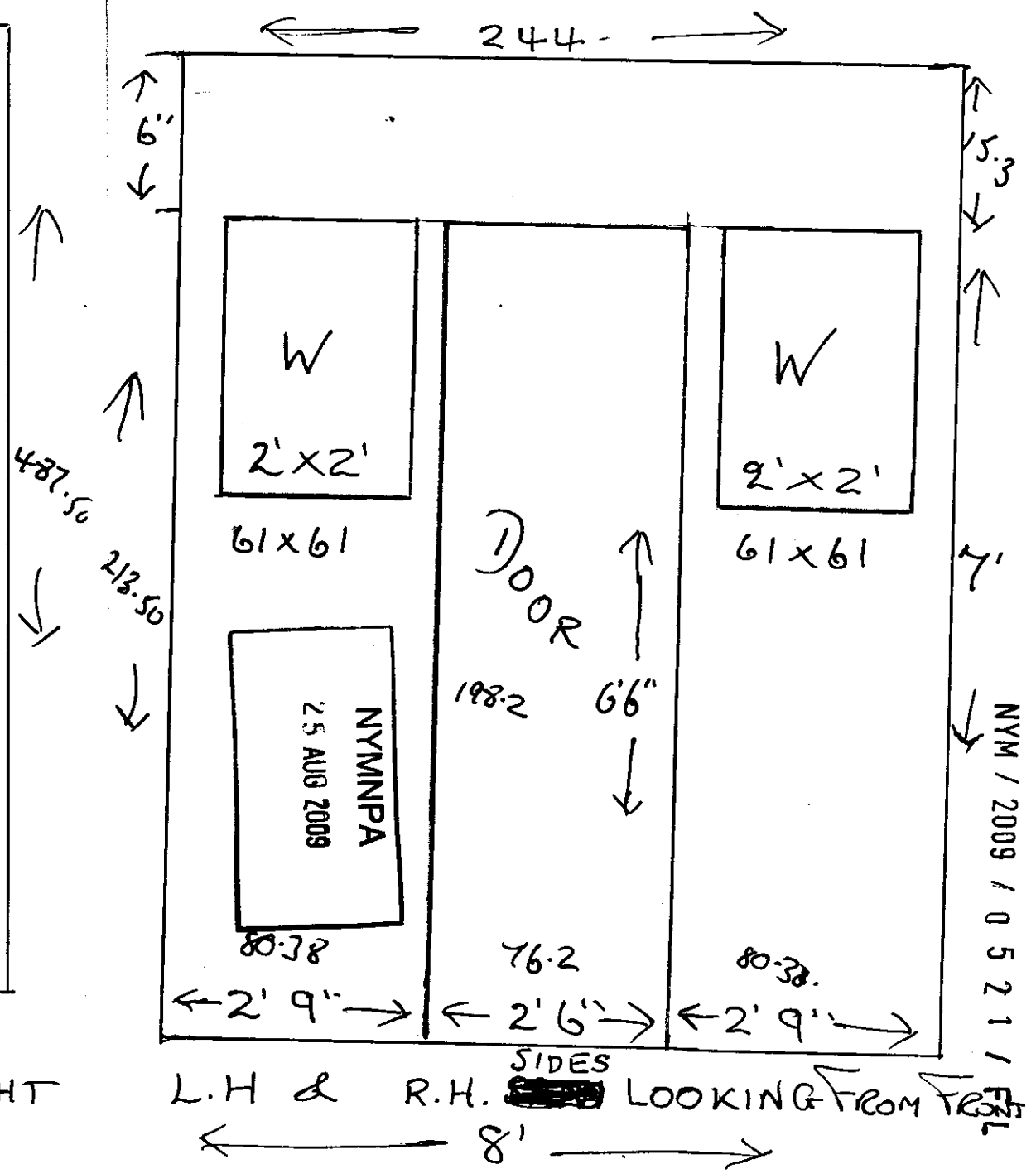

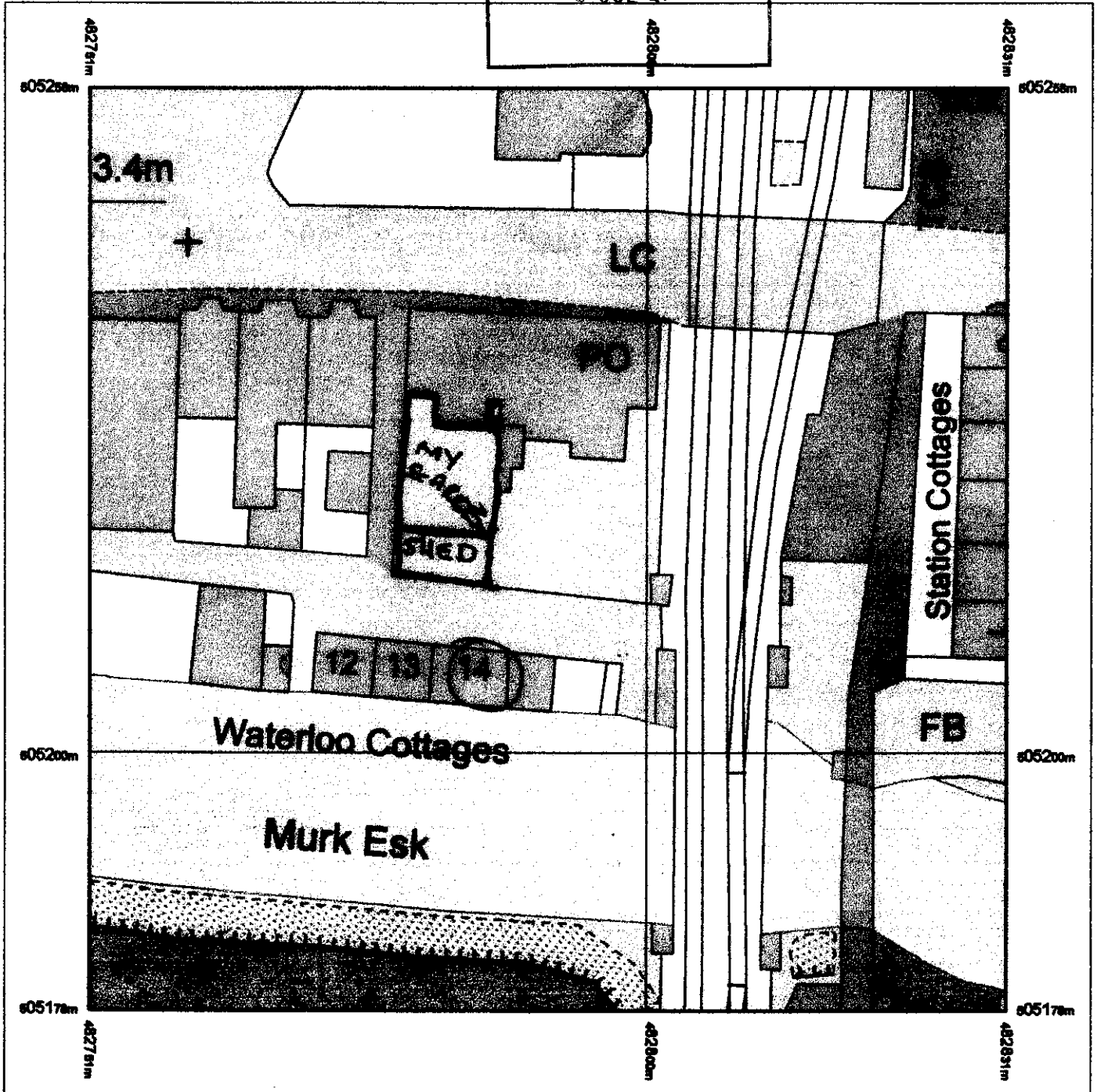


BACK OF SHED

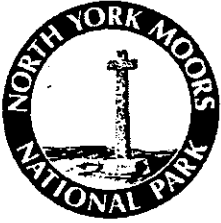

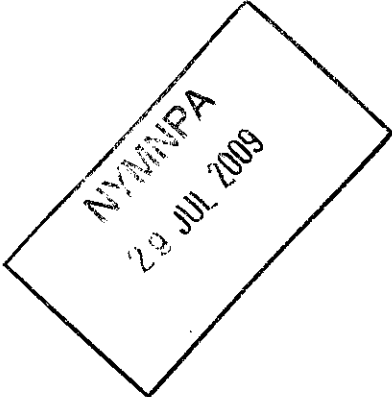

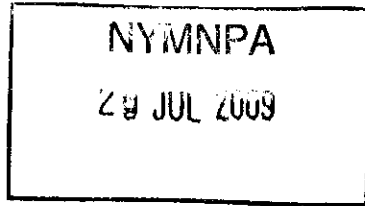
