Hi Alison,

We now attach the one of the 2 documents as requested, and we are working on the CO2 information.

At this time are we not able to agree that we will provide such information before the planning application is determined? as we are having difficulty in obtaining such detailed information on such un-detailed plans. It appears that everyone we talk to wants to see fully detailed plans of a final scheme, including the heating systems etc, which oobviouslyhave not been designed yet.

Because the buildings are Listed we are not in a position to obtain any SAP or SBEM assessments, until we have a listed building consent indicating what we are allowed to do to the floor, walls and roof and how many openings we can or can not have.

Our client is quite happy to undertake this additional design work when they have an indication of what is involved, but to do it now and then it all possibly change, would be a huge additional costing not allowed for.

I must say it is still our opinion that Core Policy D does not apply, as the 4 holiday cottages are clearly dwellings, I am told as a matter of fact in law, but just with restrictive occupancy conditions.

Please can you raise this issue with your Chief Officers so that we may be given the chance to progress the matter, bearing in mind we have now lost 8 weeks since we first deposited the application.
