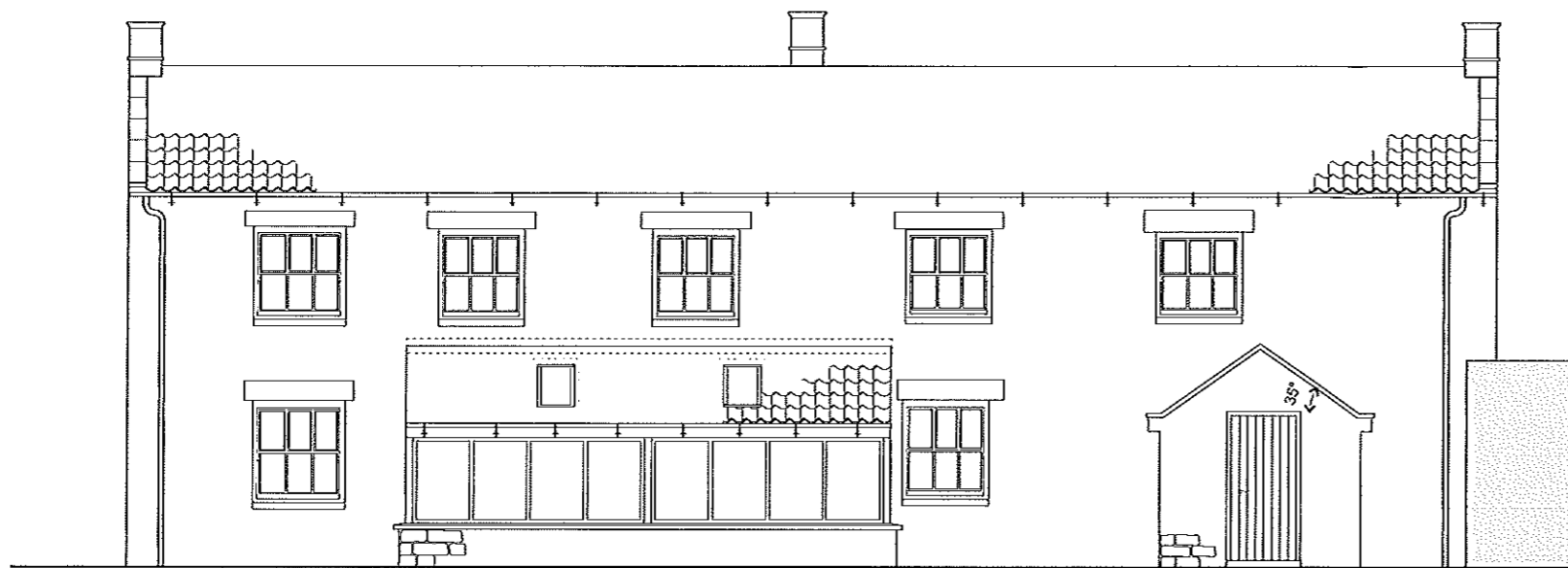

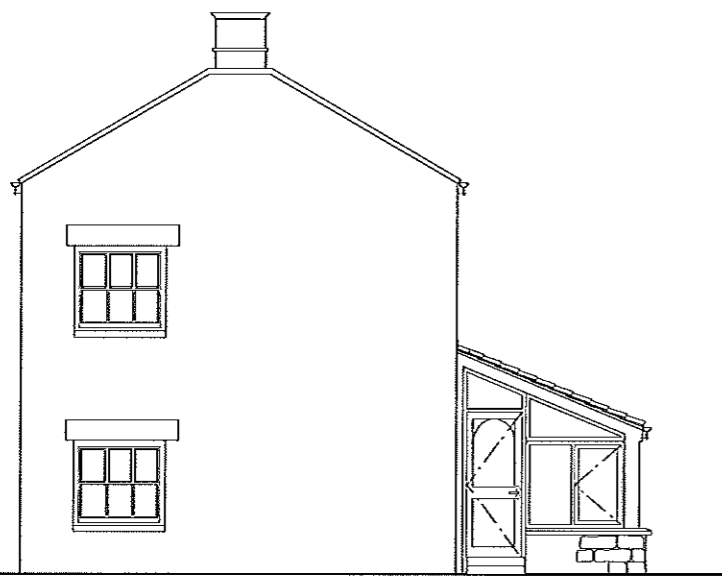


**Proposed Elevation 2**

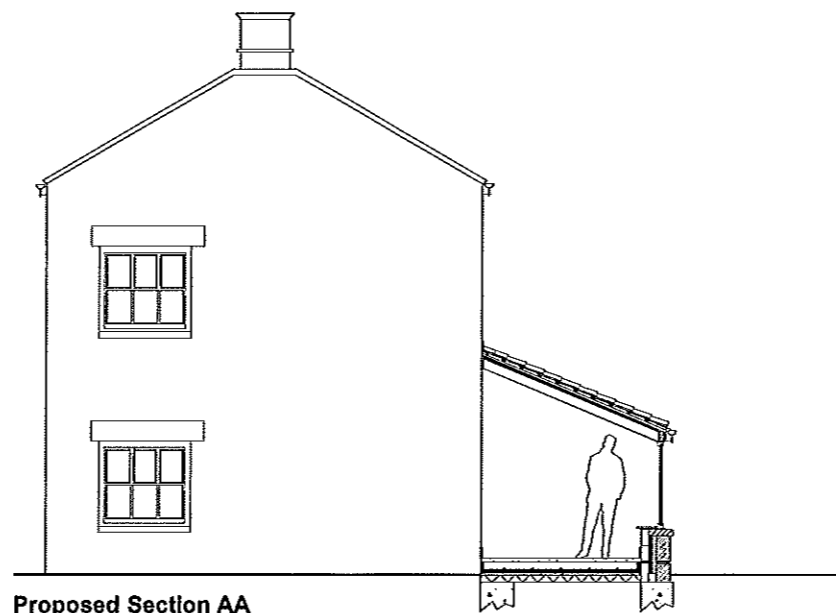

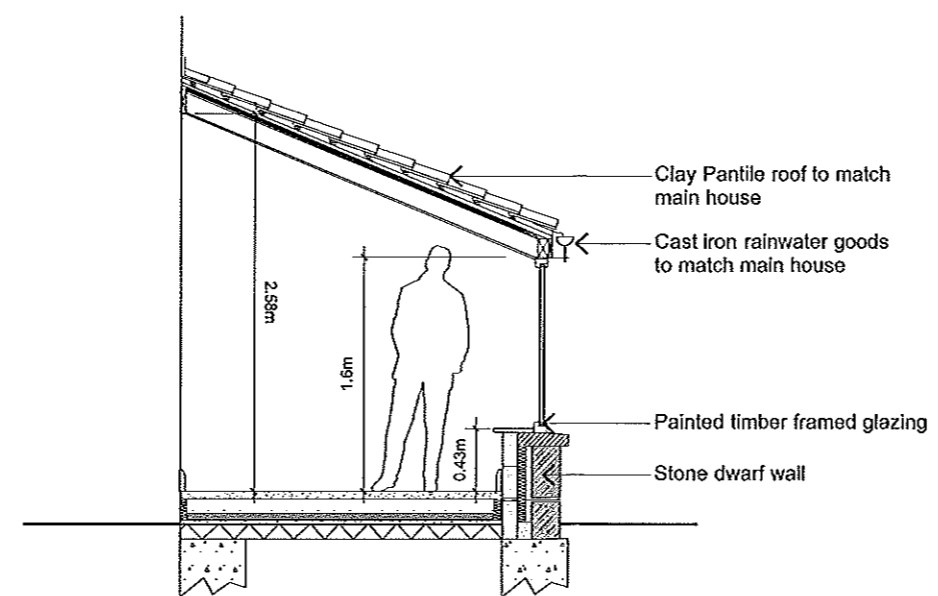

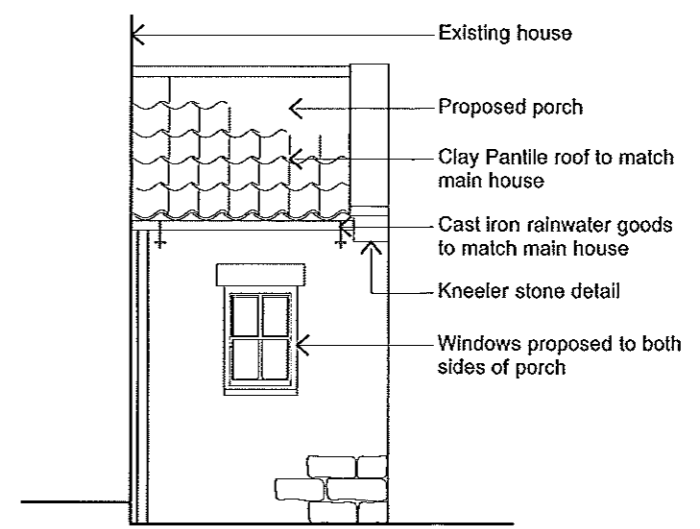
