Please see attached a site Plan from the Caravan Park.

During the rebuild works of the Toilet Block we think about 15 - 20 caravans will need to stay out or be placed elsewhere from their usual over winter area. The red outline on the attached plan shows the space intended to be used for this.

This area is adjacent to (West of) the existing unaltered Toilet Block. It utilises existing hardstandings and the access road between. The area between the 2 Toilet blocks shown on the attached Plan is also where Caravans are stored over winter, the displaced ones will be immediately adjacent.

This allows all vans from the upper slopes and the Lower fields towards the road to be taken off their pitches and stored as usual, these areas are the most visually obvious.

This arrangement is only required for one winter while the New Toilet Block is built.

In respect of existing numbers of facilities the Toilet Block to be demolished houses:-

- * 5 WC's
- * 4 Urinals
- * 2 Showers
